Had you in your hands or under your control directly or indirectly, at the time of service of these interrogatories, or at any time since, any money, rights, credits or other property whatsoever, belonging or due to the said belonging or due to the said defendant in writ, or in which he has or had any interest for the whole or for a part, and if yes, what is the nature, description and amount thereof; and is the same sufficient to pay or to satisfy the full amount of said writ, or if less to what amount ?
