LAST WILL

AND TESTAMENT

KNOW ALL MEN BY THESE PRESENTS that before me, [_NOTARY_], a Notary Public in and for the parish of [_Parish_], Louisiana, duly commissioned and qualified to act as such, and in the presence of the good and competent witnesses hereinafter named and undersigned, personally came and appeared [_TESTATRIX_], presently married to [_HUSBAND_], who stated, declared and signified she knows how and is able to read and knows how and is able to sign her name and that this instrument is her last will and testament in words as follows:

"I have been married but once and then to [_HUSBAND_]. I have only two children, [_CHILD_1_] and [_CHILD_2_]. I reside at [_Address_] and my Tax Identification Number is [_TIN_]. I revoke all wills and codicils previously made by me. At my death, I desire the following disposition of my property:

(1) I give and bequeath a lifetime usufruct without bond over all of the property of which I die possessed, movable and immovable, separate and community, and of every nature whatsoever, including all mineral rights, to my husband, [_HUSBAND_].

(2) I give and bequeath the naked ownership of all of the property of which I die possessed, movable and immovable, separate and community, and of every nature whatsoever to my descendants by roots in being at the time of my death. I now have two children, [_CHILD_1_] and [_CHILD_2_], but in the event that I have additional children, they shall share in the naked ownership of my property as provided above.

(3) I appoint my husband [_HUSBAND_] executor of my estate, with full seizing and without bond.

(4) Should my husband predecease me, I appoint [_TUTRIX_] of any minor children that I have at my death."
