With your Power of Attorney package, you will find the state specific forms that will help you prepare for and protect yourself and your loved ones from events that may affect your health, finances and personal affairs.

Included in your package are the following forms:

1. General Power of Attorney

2. Power of Attorney for Care and Custody of Children

3. Statutory Power of Attorney for Health Care

### II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms™ Power of Attorney Package are found below.

<u>General Power of Attorney</u> – This is a general power of attorney or mandate where a person appoints an agent to handle their affairs. It covers many matters including bank accounts, health, etc.

<u>Power of Attorney for Care and Custody of Children</u> – This Power of Attorney is a form which provides for the appointment of an attorney-in-fact for the care of a child or children, including health care. This Power of Attorney form requires that the signature of the person giving another the power of attorney to be notarized.

<u>Statutory Living Will</u> – This Statutory Living Will form allows you to express your wishes and desires if it is determined that your death will occur whether or not life-sustaining procedures are utilized and where the application of life-sustaining procedures would serve only to artificially prolong the dying process. It is a declaration that such procedures be withheld or withdrawn, and that you be permitted to die naturally with only the administration of medication or the performance of any medical procedure deemed necessary to provide you with comfortable care.
