With this Amendment to Lease Package, you will find the forms that are necessary to modify the terms of a lease. The forms in this package are designed to avoid disagreements over changes to leases and stay in compliance with state law.

Included in your package are the following forms:

- 3. Modification of a Lease to Extend the Term and Increase the Base Rent
- 4. Modification of Lease Agreement
- Lease Modification Adding One or More Entities as Tenant Parties

II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms[™] Amendment to Lease package are found below.

<u>Amendment of Residential Lease</u> - This Amendment of Residential Lease permits changes to a lease agreement that will be incorporated as part of the overall lease contract. The structure of this form complies with applicable state statutes.

<u>Amended Lease - Amendment for Office Building</u> - This is an amended lease for an office building. Terms for modified rent and repairs to be made are included.

<u>Modification of a Lease to Extend the Term and Increase the Base Rent</u> - This agreement allows the landlord and tenant to agree to a new lease term and make adjustments to the rent payments. Other terms may be added as needed.

<u>Modification of Lease Agreement</u> - This forms allows the landlord and tenant to make any desired changes to the lease agreement. It may be customized to include any terms agreed upon.

<u>Lease Modification Adding One or More Entities as Tenant Parties -</u> This lease clause states that the landlord and the tenant agree that the lease (sublease) is modified, and illustrates the terms and conditions of the modifications of the lease.

<u>Commercial Lease Modification Agreement</u> – This office lease agreement contains detailed terms and conditions for the modification (and extension) of the lease. Terms for the tenant's option to a further lease extension in the future are included.
