### II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms™ Employment Termination Package are found below.

<u>Summary of Rights and Obligations under COBRA</u> - This form is used to summarize a separating employee's rights and obligations under the group health continuation coverage provision of COBRA.

<u>Termination Letter (General)</u> - This form may be used to inform an employee of the decision to terminate their employment. Wages, accrued vacation and severance pay may be specified.

<u>Consent to Release of Employment Information and Release</u> -This form is a consent to the release of employment history and wage information and records. The form also releases the employer from liability in connection with providing such information.

<u>Exit Interview</u> - This form is used for a separating employee to provide valuable feedback by answering comprehensive questions covering various aspects of the company and their job experience within the company.
