7. At all times relevant hereto, the Defendants negligently and carelessly maintained and operated the airplane in which Plaintiff was a passenger. As a direct and proximate result of this negligence and carelessness, Plaintiff received serious personal injuries some of which are permanent. As a result, Plaintiff suffers continuous physical pain and mental distress and suffers a permanent diminished capacity to enjoy life. The negligence exhibited by all Defendants

causing Plaintiff's head to strike the ceiling of the plane.

causing the accident consists of a reckless and willful disregard for the rights and safety of Plaintiff and others and entitle Plaintiff to punitive damages.
8. Plaintiff is entitled to damages against all Defendants to compensate him/her for nedical bills for treatment and care both past .
WHEREFORE, PREMISES CONSIDERED, Plaintiff prays for judgment against Defendants in the amount of \$ compensatory damages and \$ exemplary damages.
