Other useful forms are also included to assist Newly Widowed Individuals get their legal life in order.

#### **II. DESCRIPTIONS OF FORMS**

Brief descriptions of the forms contained in your U.S. Legal Forms<sup>™</sup> Personal Planning Package are found below.

<u>Affidavit of Heirship</u>- This Heirship Affidavit form is for a person to complete stating the heirs of a deceased person. The Heirship Affidavit is commonly used to establish ownership of personal and real property. It may be recorded in official land records, if necessary. Example of use: Person A dies without a will, leaves a son and no estate is opened. When the son sells the land, the son obtains an heirship affidvait to record with the deed. The person executing the affidavit should normally not be an heir of the deceased, or other person interested in the estate.

<u>General Power of Attorney Effective Immediately</u> -This General Power of Attorney is a general power of attorney which is effective IMMEDIATELY. You can use this form to appoint an attorney-in-fact (agent) to make decisions regarding property, financial, banking, management, business and other matters for you. The powers granted to an Agent in this Power of Attorney are very broad, but this Power of Attorney does NOT provide for health care services. This form complies with all applicable state statutory laws.

<u>Revocation of General Power of Attorney</u> -This is a Revocation of the General Power of Attorney which allow you to appoint an attorney-in-fact (agent) to make decisions regarding property, financial, management, banking, business and other matters for you. Specific reference is made to the previously executed power of attorney and the date of its execution.

<u>Advance Health Care Directive - Statutory Form, including living will provisions</u> - This is a statutory form provided in the Mississippi Code that allows you to give instructions about your own health care, name someone else to make health-care decisions for you and designate a physician to have primary responsibility for your health care. An adult or emancipated minor may provide instructions regarding their health care either orally or in writing and may execute a power of attorney for health care, which may authorize an agent to make any health-care decision the principal could have made while having capacity. The power must be in writing, dated, signed and either witnessed by at least two individuals (each of whom witnessed either the signing of the instrument by the principal or the principal's acknowledgement of the signature or of the instrument) or acknowledged before a notary public at any place within Mississippi.

<u>Personal Planning Information and Document Inventory Worksheets - A Legal Life Document</u> -This form enables you to document matters relevant to your life and personal planning such as the location of your important legal documents, relatives names, contact information, medical information, financial asset inventory and more.
