# I. FORM LIST

### II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms™ Personal Planning Package are found below.

<u>Last Will and Testament</u> – Complete this form to detail in writing your wishes regarding who is to receive your property at death and who will administer your estate. It also enables you to appoint trustees or guardians, if applicable.

<u>Statutory Health Care Directive</u>- This is a statutory form that is provided in the North Dakota Century Code that allows you to appoint an individual as your agent with regard to healthcare decisions when you are no longer capable of making them yourself. It includes broad power to make physical and mental health treatment decisions.

<u>General Power of Attorney</u> – Complete this form to give a person whom you choose (the agent) to give the power to manage your assets and financial affairs while you are alive. The document must be signed by you (the principal) while you have the required legal capacity to give your agent clear and concise instructions. The appointment may be for a fixed period and can be revoked by you at any time providing you still have the legal capacity to do so. A power of attorney ceases when you die. The executor named in your will then takes over the responsibilities of your estate.

<u>New Resident Guide</u> - This is an informational form that details for new residents the various state requirements for residency, voter registration, identification cards, driver's licenses, and vehicle title and registration.
