#### **II. DESCRIPTIONS OF FORMS**

Brief descriptions of the forms contained in your U.S. Legal Forms<sup>™</sup> Employment Employee Personnel File package are found below.

<u>Employee 90 Day Review Report</u> – This is an evaluation form that is used when a new employee has been employed beyond the 90-day probation period.

<u>Employment Form</u> - This form allows a supervisor to collect vital employment information from an employee.

<u>Direct Deposit Authorization Agreement</u> – This form, to be filled out by the employee, allows the employer to deposit payroll checks directly into an employee's bank account.

<u>Employment Agreement</u> – This employment agreement is between a company and an employee. The company desires that the employee will not compete with the company during a certain length of time and within a certain geographical area specified within the agreement. The form also contains sections concerning: compensation, office and duties, termination of employment, and confidentiality.

<u>Absence Report</u> – This form is used to keep track of employee absenteeism and the reasons for their absence. This form requires the signature of both the employee and the employer.

<u>Payroll Deduction Authorization</u> – This form is used by the employee to authorize payroll deductions for a series of services.

<u>Accident Injury Report</u> – This form is used to document accidents and/or work-related injuries.

<u>Expense Report</u> – This expense report may be used to document amounts paid for meals, entertainment, supplies, etc.

<u>Employee Monthly Time Report</u> – This time report is used to track the work hours of a nonexempt employee.

<u>Wage Withholding Authorization</u> – This form is used as an authorization form for those employees wishing to have wages withheld from their paychecks. This form requires both the employee and the employer's signature.

<u>Vacation Request</u> – This form must be filled out and submitted by an employee requesting vacation time.

<u>Confidentiality Statement</u> - This form is a statement of your company's confidentiality Agreement and must be signed by both the employee and a witness.

<u>Handbook Acknowledgement Form</u> - This form is an agreement and acknowledgement that the employee has received and understands the company handbook. This form requires the signature of both the employee and employer.

<u>Workers' Compensation Acknowledgement Form</u> - This is an acknowledgement form regarding workers' compensation. The form states that the employee has read and understands the workers' compensation guidelines.
