### **II. DESCRIPTIONS OF FORMS**

Brief descriptions of the forms contained in your U.S. Legal Forms<sup>™</sup> Annual Financial Check Up Package are found below.

<u>Last Will and Testament</u> - This state-specific form details in writing your wishes regarding who is to receive your property at death and who will administer your estate. It also enables you to appoint trustees or guardians, if applicable.

<u>New Mexico Statutory General Power of Attorney with Durable Provisions</u> - This is a statutory form, that is, it is provided in the New Mexico Statutes Annotated. By using this form, you can create a general, limited, or durable Power of Attorney. This form allows you to appoint an attorney-in-fact (agent) to make decisions regarding property, financial, business, insurance or other matters for you.

<u>Estate Planning Questionnaire and Worksheets</u> - This state-specific form is used for estate planning purposes and contains personal and financial information, including details regarding your home and other property you own and additional assets including investments, life insurance policies and individual retirement accounts.

<u>Retirement Cash Flow-</u> This multi-state form allows retired persons to determine their available funds for savings and investments for themselves and a spouse based upon itemized retirement income, taxes, and living expenses.

<u>Personal Monthly Budget Worksheet</u>- This multi-state form allows you to enter amounts into itemized categories for income and expenses in order to plan and organize your financial affairs. It will calculate monthly totals for income and expenses, as well as any money remaining after all expenses are paid.

<u>Cash Flow Statement-</u> This multi-state form is used for budgeting purposes to show incoming and outgoing income and expenses of a typical household.

<u>Credit Report Request Form</u>- This multi-state form allows an individual to request his or her annual free credit report allowed by federal law from each of the credit bureaus through the Annual Credit Report Request Service, which is the centralized source for consumers to request this annual credit report.

<u>Financial Statement Form for Husband and Wife</u>- This multi-state form is a statement of assets and liabilities of a husband and wife using joint finances. The form contains sections to identify current assets, current liabilities, deferred assets, and net worth.

<u>Financial Statement Form for Individual</u>- This multi-state form is a statement of assets and liabilities of an individual. The form contains sections which ask the individual to identify current assets, current liabilities, deferred assets, and net worth.
