II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms™ Living Will package are found below.

<u>Statutory Durable Power of Attorney for Health Care</u> - Generally, all states have special laws providing how a power of attorney must be prepared and executed. Generally, if the Power of Attorney is to be recorded, a state specific acknowledgment must also be used. Some states also prescribe a recommended form of power of attorney. Therefore, this is generally a state specific form.

<u>Revocation of Statutory Durable Power of Attorney for Health Care</u> - This is a form for the revocation of the Durable Power of Attorney provided in Form OH-P016.

Statutory Equivalent of Living Will or Declaration concerning the use of life sustaining treatment This form is a Declaration Concerning the Use of Life Sustaining Treatment. The declaration must be witnessed by two people or acknowledged by the declarant before a notary public.

<u>Revocation of Statutory Equivalent of Living Will or Declaration</u> - This form is a revocation of a Declaration Concerning the Use of Life Sustaining Treatment provided in form OH-P024.

<u>Uniform Anatomical Gift Act Donation with Donor Registry Enrollment Form</u> – This Uniform Anatomical Gift Act Donation form pursuant to state statutes designates the specific body parts and organs an individual wishes to donate at the time of death. Any individual eighteen years of age or older and of sound mind may make an anatomical gift for any statutorily specified purpose by execution of a document of gift or by will. If a person less than eighteen years of age wishes to make an anatomical gift, one of the witnesses who signs the document shall be a parent or guardian of that person. This form must be witnessed and the signature notarized. This form also includes the necessary enrollment form for the Donor Registry managed by the Ohio Department of Motor Vehicles.

Anatomical Gift by a Relative or the Guardian of the Person of a Decedent - This form designates the body parts and organs of a decedent which a relative or the guardian of the person of a decedent wishes to donate at the time of the decedent's death. See Ohio Revised Code, Chapter 2108.
