#### **II. DESCRIPTIONS OF FORMS**

Brief descriptions of the forms contained in your U.S. Legal Forms<sup>™</sup> Personal Planning Package are found below.

<u>Last Will and Testament</u> – Complete this form to detail in writing your wishes regarding who is to receive your property at death and who will administer your estate. It also enables you to appoint trustees or guardians, if applicable. **(control number varies)** 

<u>General Durable Power of Attorney</u> – This General Durable Power of Attorney is a general, durable power of attorney which is effective IMMEDIATELY. This form allows you to appoint an attorney-in-fact (agent) to make decisions regarding property, financial, business, banking, management and other matters for you. The powers granted to an Agent in this Power of Attorney are very broad, but do NOT provide for health care services. This form complies with all applicable state statutory laws. **(OR-P003A)** 

<u>Statutory Power of Attorney for Mental Health Care</u> - This is a statutory form provided for in the Oregon Revised Statutes that provides for the appointment of a mental health care representative and for specific instructions for mental health treatment when you are no longer capable of expressing your consent or refusal for treatment. also select for the form to be durable, which means that it continues if you become incompetent. **(OR-P018)** 

<u>Health Care Directive - Advanced Health Care Directive - includes Living Will and Health Care</u> <u>Decisions Statutory Form</u> - This is a statutory form that is provided for in the Oregon Revised Statutes and provides a means for you to express health care choices and decisions, notably decisions about life support and tube feeding. It allows you to appoint a health care representative and to give specific instructions about your health care. **(OR-P021)** 

<u>Statutory Equivalent of Living Will</u> - Request for Medication to End Life - Statutory Form - This form allows you to express your wishes and desires regarding whether or not your life is prolonged by artificial means. You are also given the option to make an anatomical gift. **(OH-P024)** 

<u>Estate Planning Questionnaire</u> – Complete this form to assist attorneys, estate planners, and other professionals with details regarding your home and other property you own and additional assets including investments, life insurance policies, individual retirement accounts and so forth so that they can best recommend a course of action regarding your estate. **(OH-WIL-801)** 

<u>Personal Planning/Documents Inventory Form</u> – Complete this form to retain important information on file relevant to your life such as names of relatives, their contact information, your medical information, financial asset inventory, the location of your important legal documents and more. **(OR-WIL-801)** 

<u>Financial Statement Form – Universal Use</u> - This form outlays the assets and liabilities of an individual. The form contains sections which ask the individual to identify the following: current assets, current liabilities, deferred assets, and net worth. **(US-00522-J)**

By clicking on the appropriate form field, you will be able to enter the needed information. In some instances, the form field and the line will disappear after information is entered. In other cases, it will not. The form was created to function in this manner.
