With your Power of Attorney package, you will find the state specific forms that will help you prepare for and protect yourself and your loved ones from events that may affect your health, finances and personal affairs.

Included in your package are the following forms:

- General Durable Power of Attorney for Property and Finances Effective Upon Disability

# II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms<sup>™</sup> Power of Attorney Package are found below.

General Durable Power of Attorney for Property and Finances Effective Upon Disability – This General Durable Power of Attorney for Property and Finances Effective upon Disability form is a general, durable power of attorney which is effective ONLY upon the principal's disability, incompetency or incapacity. This form allows you to appoint an attorney-in-fact (agent) to make

decisions regarding property, financial, business, banking, management and other matters for you. The powers granted to an Agent in this Power of Attorney are very broad, but do NOT provide for health care services.

General Durable Power of Attorney for Property and Finances Effective Immediately - This General Durable Power of Attorney is a general, durable power of attorney which is effective IMMEDIATELY. This form allows you to appoint an attorney-in-fact (agent) to make decisions regarding property, financial, business, banking, management and other matters for you. The powers granted to an Agent in this Power of Attorney are very broad, but do NOT provide for health care services. This form complies with all applicable state statutory laws.

<u>Power of Attorney for Care and Custody of Children</u> – This Power of Attorney is a form which provides for the appointment of an attorney-in-fact for the care of a child or children, including health care. This Power of Attorney form requires that the signature of the person giving another the power of attorney to be notarized.

<u>Statutory Advance Health Care Directive</u> – This is a statutory form that allows you to express your wishes and desires and give instructions regarding your health care such as whether you wish your life to be prolonged by artificial means. You can also use this document to name someone else to make health care decisions for you, to express your wishes regarding anatomical gifts of bodily organs and tissues and to designate a physician to have primary responsibility for your health care. You must sign this form and have two other individuals sign as witnesses.
