In consideration of the matters described above, and of the mutual benefits and
obligations set forth in this agreement, the parties agree as follows:

I. Complainant and Defendant submit personally to the jurisdiction of the ___ Judicial
District Court of _____ County, _____ (State).

II. Defendant consents to entry of judgment in accordance with the terms of this agreement.

III. Defendant desires and does hereby agree to give up all rights to custody of _____ (*Name of Child*) in favor of Complainant immediately upon issuance of a decree to that effect by said Court.

IV. Complainant is a fit and proper person to have and be awarded the custody, care, and control of _____ (*Name of Child*), and Complainant is willing to assume, and desirous of assuming, sole responsibility for the custody, care, and education of _____ (*Name of Child*) and a permanent and suitable home would be provided for said child with Complainant.

V. Complainant shall have exclusive custody of _____ (*Name of Child*), but with the right of Defendant to visit said child at reasonable times and under reasonable conditions and circumstances.

VI. Neither party shall disparage or criticize the other in the presence of _____ (*Name of Child*) or attempt in any way to influence said child against the other party.

VII. Complainant will, upon entry of the appropriate decree by the ___ Judicial District Court of _____ County, _____ (*State*) assume sole responsibility for the custody, care, and education of _____ (*Name of Child*).
