II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms[™] Employee Confidentiality Agreements and Trade Secrets Package are found below.

<u>Non-disclosure and Confidentiality Agreement by Employee or Consultant to Owner</u> – The first party has possession of proprietary information and know-how relating to an idea, product or service, and wishes to employ the second party but desires that the second party agree not to disclose information learned by second party during such employment. Both parties agree that all information, ideas, products or services, processes, written material, samples, models and all

Other information of any type, whether written or oral, submitted to the second party by the first party is now, and will remain, the property of first party.

<u>Confidentiality Agreement</u> - This agreement provides that the recipient of confidential information will not disclose the information to any other unauthorized party.

<u>Confidentiality Agreement between Companies</u> – This form constitutes an agreement between two companies regarding information or ideas valuable to the company's business. Any such information or ideas is treated as confidential and should not be disclosed to competitors or freely made available to other third parties.

<u>Non-Disclosure Agreement</u> – The parties to this agreement desire that the Disclosing Party will make certain Subject Information available to the Receiving Party for use in connection with a potential or actual business relationship elsewhere defined, and that the Receiving Party will protect such Subject Information.
