II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms Photography and Modeling Package are found below.

<u>Release and Authorization to Photograph</u> - The following form authorizes a photographer to make photographs of a subject and use the photographs as still photographs, transparencies, motion pictures, television, video or other similar media.

Release and Authorization to Record Picture and / or Voice On Photographs, Films, Audio and / or Videotapes - The following form authorizes a photographer, record company, motion picture company, or a similar such person or business, to record the picture and/or voice of a person on photographs, films, audio and/or videotapes, and to use same in still photographs, transparencies, motion pictures, television, video or similar such media.

Assignment of Rights, Consent to Publication and Release - Use of Photographs - The seller assigns, transfers, and sells to the purchaser photographs for commercial and non-commercial publication. - The seller also acknowledges that he/she is relinquishing all rights to the photos and any future compensation for publication of the photos.

<u>Freelance Photographer Agreement - Independent Contractor</u> - This is an agreement between an employer and a freelance photographer to provide various photographic services for employer as an independent contractor.

<u>Model Permission to Photograph</u> - This is a form signed by a model permitting a photographer or agency rights to photograph the model and gives consent for the photographer to publish, republish, copyright, sell, or display any image of the photograph in any forum. This form also covers any purpose for which the agency may want to use the picture.

<u>Contract Between Photographer and Model to Produce and Sell Photographs Agreement</u> <u>between Photographer and Purchaser of Photographs</u> - This is a sample contract between a photographer and a company to make photographs for the company for commercial use.

Photograph License Agreement - USLF offers many handbooks on various legal issues. This particular book serves as a guide to the subject of photograph licensing agreements.

By clicking on the appropriate form field, you will be able to enter the needed information. In some instances, the form field and the line will disappear after information is entered. In other cases, it will not. The form was created to function in this manner.
