With your Mini Storage and Self-Storage package, you will find the essential forms to define the rights and obligations involved and deal with customer defaults.

II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms™ Mini Storage and Self-Storage Package are found below.

Notice of Belief of Abandonment of Leased Premises – This is a Notice to Tenant of Lessor's belief of Tenant's abandonment of the leased premises. Warning to Tenant is included that consequences including termination are forthcoming.

Storage Services Contract - This a contract between a independent storage contractor for storage of goods. Provisions are included for services to be provided, including terms of service, risk of loss, insurance, warranties, and more.

Lease for Storage of Goods - This form is designed and used for the purpose of renting or leasing individual storage space to occupants who are to have access to such for the purpose of storing and removing personal property. "Personal property" means movable property not

affixed to land and includes, but is not limited to, goods, merchandise and household items. A "Warehouseman" is a person engaged in the business of storing goods for hire. A warehouseman may liable for damages for loss of or injury to the goods caused by his failure to exercise such care in regard to them as a reasonably careful man would exercise under like circumstances. Therefore it is important to state in the agreement that the Lessee is not a warehouseman but is merely renting space.

Notice of Sale to Satisfy Lien of Self-Service Storage Facility – A self-service storage facility has been defined as "any real property designed and used for the purpose of renting or leasing individual storage spaces to occupants who are to have access to such for the purpose of storing and removing personal property." Such a business has generally acquires a statutory lien on the stored property for unpaid storage costs.

<u>Lease of Storage Space for Household Goods</u> - This is a lease of storage space for household goods, with the lessee retaining possession and control over the goods. Provisions are made for terms of access, rental terms, responsibilities and liabilities of the respective parties, remedies for breach of the agreement, and more.
