### II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms™ Personal Planning Package are found below.

<u>Last Will and Testament</u> – Complete this form to detail in writing your wishes regarding who is to receive your property at death and who will administer your estate. It also enables you to appoint trustees or guardians, if applicable.

<u>Advance Healthcare Directive</u> - This Utah Statutory Advance Health Care Directive allows you to express your wishes and desires regarding whether or not your life is prolonged by artificial means. You may also name another person to make health care decisions for you when you cannot make decisions or speak for yourself, donate anatomical gifts, and other options.

General Power of Attorney – Complete this form to give a person whom you choose (the agent) to give the power to manage your assets and financial affairs while you are alive. The document must be signed by you (the principal) while you have the required legal capacity to give your agent clear and concise instructions. The appointment may be for a fixed period and can be revoked by you at any time providing you still have the legal capacity to do so. A power of attorney ceases when you die. The executor named in your will then takes over the responsibilities of your estate.

<u>New Resident Guide</u> - This is an informational form that details for new residents the various state requirements for residency, voter registration, identification cards, driver's licenses, and vehicle title and registration.
