### II. DESCRIPTIONS OF FORMS

Brief descriptions of the forms contained in your U.S. Legal Forms™ Personal Planning Package are found below.

<u>Last Will and Testament</u> – Complete this form to detail in writing your wishes regarding who is to receive your property at death and who will administer your estate. It also enables you to appoint trustees or guardians, if applicable. **(control number varies)** 

General Durable Power of Attorney – This General Durable Power of Attorney is a general, durable power of attorney which is effective IMMEDIATELY. This form allows you to appoint an attorney-in-fact (agent) to make decisions regarding property, financial, business, banking, management and other matters for you. The powers granted to an Agent in this Power of Attorney are very broad, but do NOT provide for health care services. This form complies with all applicable state statutory laws. (WA-P003A)

<u>Durable Power of Attorney for Health Care</u> - This form gives the person you name as your agent the authority to make any and all health care decisions for you in accordance with your wishes when you are no longer capable of making them yourself. **(WA-P015)** 

<u>Mental Health Advance Directive - Statutory Form</u> - This form designates individual choices concerning mental health care. These choices will be carried out in the event the individual creating the directive becomes unable to express his/her instructions and preferences regarding his/her mental health care. **(WA-P026)** 

<u>Statutory Equivalent of Living Will</u> - This is a statutory form that is provided for in the Revised Code of Washington. This form allows you to express your wishes and decision that your dying not be artificially prolonged under certain circumstances set out in the directive. **(WA-P024)** 

<u>Estate Planning Questionnaire</u> – Complete this form to assist attorneys, estate planners, and other professionals with details regarding your home and other property you own and additional assets including investments, life insurance policies, individual retirement accounts and so forth so that they can best recommend a course of action regarding your estate. (**WA-WIL-801**)

<u>Personal Planning/Documents Inventory Form</u> – Complete this form to retain important information on file relevant to your life such as names of relatives, their contact information, your medical information, financial asset inventory, the location of your important legal documents and more. **(US-00PPF)** 

<u>Financial Statement Form – Universal Use</u> - This form outlays the assets and liabilities of an individual. The form contains sections which ask the individual to identify the following: current assets, current liabilities, deferred assets, and net worth. **(US-00522-J)**

By clicking on the appropriate form field, you will be able to enter the needed information. In some instances, the form field and the line will disappear after information is entered. In other cases, it will not. The form was created to function in this manner.
