This form also contains notice to the lessee or tenant of the assignment and a new address to which future rental payments should be sent.

<u>Landlord Consent to Assignment of Lease</u> - This multi-state form is used by a landlord to consent to a tenant assigning his or her leasehold interest in a lease agreement to a new tenant.
