## **LEXCEN TRAVEL GRANT 2008-2009 SAILING SEASON**

### CONDITIONS & RULES

1. The Regatta shall be held between the 1<sup>st</sup> July 2008 to the 30<sup>th</sup> June 2009 inclusive.
2. The applicant must be **between the ages of 15 - 20 years** at the date of the first race of the regatta and must be eligible to compete in the regatta as a junior/youth entrant.
3. The applicant(s) must be a Registered Sailor Member(s) of a Club affiliated with Yachting SA and during the time under review be a resident(s) of South Australia.
4. The regatta may be either a National and/or an International competition.
5. Applications on the Official Form may be made on behalf of the youth sailor(s) by any Member Club or Association affiliated with Yachting SA and shall be signed by the Commodore or President or Secretary of that body.
6. Nominations shall not be accepted after 5.00pm on Friday 5th December 2008.
7. Selection shall be by the Board of Yachting South Australia, and the Board shall not allocate a grant, if in their opinion, an applicant does not meet the criteria required.
