Thank you for your recent payment for flood insurance. In order to continue processing your PFA policy, we are required to obtain your signature on the enclosed form. We have provided a postage paid envelope as well as a copy of the form for your convenience.

If we do not receive the Signed **Disclosure/Acknowledgement Form** required to issue the Private Flood by the effective date of the NFIP policy we will be required to issue you a NFIP policy. Since the NFIP policy requires an additional premium payment, we will need you or your lender to submit the extra funds to keep your coverage at the current limits. If we do not receive these funds by the effective date of the NFIP policy, your policy will be issued at reduced coverages up to the amount of funds received. You may use the enclosed postage paid envelope for your convenience.
