#### **Responses to Vendor Questions**

**Question:** On page 11, the Statement of Liability states that 'the Contractor's liability for damages to the State shall be limited to the value of the Contract or \$10,000,000, whichever is higher.' Is the Awarded Contractor expected to carry \$10,000,000 of errors and omissions insurance and/or general liability insurance for the work associated with this RFP?

**Answer:** This was erroneous wording and should have stated 'whichever is *lower*.' Further, AEO will not require any proof of liability insurance in this RFP response.

**Question:** On page 12 and 15 there are references to 'proposal pricing' and the 'Official Proposal Price Sheets'. However, it is our assumption that pricing will not be established as a part of this response to the RFP. Is this correct?

**Answer:** The omission of pricing criteria was an oversight on AEO's part. Details on required information for this RFP may be found in this addendum.

**Question:** Will notification of award be on or before July 8th?

**Answer:** After issuing this addendum, AEO has extended the deadline for submissions of this RFP to July 8<sup>th</sup>. AEO tentatively expects to complete its evaluation and notify Awarded Contractors by the end of July 2016.

**Question:** This RFP references pricing. I'm assuming that AEO is asking for our rate schedule? Do you have any further details on the overall fee structure for these projects?

**Answer:** Yes, details may be found in this addendum.

Question: Should the overall structure of the proposal follow the Criteria table provided?

**Answer:** Proposals may follow any format respondents see fit, though following the format delineated in the Criteria table will allow AEO to evaluate proposals in the most expedient fashion.
