STUDENT RESPONSIBILITIES

Register for the correct classes	<ul style="list-style-type: none"> • Classes outside your major cannot be certified • Classes (with passing grade) cannot be certified if repeated. Credit from other colleges must be a "B" or higher to transfer to FBBC. • Class Audits, Online classes or Independent Studies cannot be certified for clock hours or tuition/fees at FBBC. • Classes cannot be certified if taken at other FBBC campuses; only Day and Evening classes in the Associate Degree Program at the main campus can be certified.
Reporting Enrollment	Chapter 30, 35, 1606, 1607 are required to report enrollment status on the last calendar day of each month at www.gibill.va.gov/wave/index.do or by calling 1-877-823-2378
Enrollment Status	Enrollment status is based on the number of enrolled hours each quarter. FBBC uses "clock-hours" when certifying with VA. This equates hours to "semester hours" used by most colleges.
Satisfactory Academic Progress	You must maintain a 2.0 GPA. If you fall into Academic Probation, your VA benefits will be terminated. If you fail a course due to absences in class, you may be required to repay VA benefits.
Changes in Class Schedule	You must notify any changes in your quarter schedule to the SCO (adds or drops) immediately. Changes may affect your VA education benefits.
Reporting Personal Information Changes	You are required to report address and direct deposit changes to VA via WAVE at www.gibill.va.gov/wave/index.do or by calling 1-877-823-2378.
Tuition and Fees	Approved T&F are paid direct to FBBC each quarter by the GI Bill and posted to your student account. Any housing allowance or book stipend will be paid directly to you from VA. You are responsible for paying any fees the VA does not pay to the college (room, board, books, deposits, etc).
Graduation	FBBC requires 125 credit hours to graduate with the Associate Degree-Religion/Christian Ministries. You are required to notify the SCO at the beginning of the quarter you intend to graduate.
