I confirm that the information submitted by me is true, correct, and complete. I authorize the City of Corpus Christi, Texas to conduct an investigation to confirm that the information submitted by me on this release form, my application, and any other documents I have provided, is true and correct. I consent for individuals and organizations to provide accurate and complete responses to the City of Corpus Christi's background investigation.

I voluntarily authorize and request, without reservation, any party or agency contacted by the City of Corpus Christi, Texas to furnish requested information as described below. I hereby release and discharge the City of Corpus Christi, Texas and its agents from all claims, demands, actions, liabilities and damages of whatever kind for providing and/or confirming information about me in response to the City of Corpus Christi, Texas investigation which may include, but not be limited to, the following information:

Verification of any military record, education, general reputation, criminal record, driving record and licenses, other records required of the permit, employment history (including terminations, eligibility for rehire, work performances and habits, abilities, and other qualities) pertinent to my application for a Vehicle for Hire Driver's Permit.

False replies to any questions herein will result in refusal of permit or, if granted, in revocation of same. The application must be properly filled out and all questions must be answered. Character references must be in good repute and acceptable to the Vehicle for Hire Inspector and have at least one year of acquaintance with the applicant. The undersigned agrees to conform to all rules and regulations of the Vehicle for Hire in the City of Corpus Christi, Texas and as specified in Sec. 57-20 thru Sec. 57-140 and Sec. 23-74 of the City of Corpus Christi, Texas Code of Ordinances.

I understand that should I refuse to sign this release form, I will be disqualified from consideration for a Vehicle for Hire Driver's Permit. A photocopy of this release form will be valid as an original thereof, even though said photocopy does not contain an original writing of my signature.
