## NATIONAL BY-LAWS CHANGE **IN REGARDS TO THE MEN'S AUXILIARY**

Comrades, Brothers and Sisters of the VFW Auxiliary and the Men's Auxiliary.

As most of you may have heard a decision regarding the future viability of the Men's Auxiliary has been reached. At the 117 VFW National Convention held in Charlotte North Carolina a vote was taken on the council floor. But let me take a step back and describe how it unfolded.

There were five separate by-law changes put before the by-laws committee. Three had to deal with disbanding the Men's Auxiliary. One of the other ones was to let the Men's Auxiliary continue unimpeded by the National Organization. The last one was put through by the Department of Minnesota to change the name of the Men's Auxiliary to an ancillary team and let those Post's that had a current Men's Auxiliary to keep them unchanged and create a grandfather clause where currently Chartered Men's Auxiliaries' would be allowed to continue to exist but, no New Charters would be issued. As you can imagine the one that came out of committee was the complete and total disbandment of the Men's Auxiliary effective December 31st, 2016.

Upon the convention floor when the by-law change was recommended by the committee much discussion ensued. The idea of Grandfathering was brought up, as was a complete change of date to some place in the future. Both proposals had Departments arguing for either of the two alternative ideas and to vote the motion of disbandment down. The debate took around thirty minutes which is the longest debate that I have experienced at the National Convention on one motion. Unfortunately the motion was passed. The Department of Minnesota, along with many other department voted no to the proposal. The motion passed but just barely. Now we need to live with the ruling on the Convention floor and prepare for the December 31st, 2016 deadline.

I would urge all of my Auxiliary brothers to join the VFW Auxiliary. In Posts across the Nation Men have flocked to the new VFW Auxiliary. It is creating a stronger VFW. I am unsure of the hesitation of some. The Men's Auxiliaries were created to help the Post in achieving its mission of service to the community. There is absolutely no reason that this cannot continue. The biggest change is that now the men that are closely related to veteran can and do now have recognition at the National Level. Many men have taken on leadership positions within their Post and District. Some state's, such as Minnesota have men in their respective department chairmanship's.

What happens now is if the men would like (and I hope you do) to continue on with the works that you were doing for your local Post, you need (if you haven't already) apply to become a member of the VFW Auxiliary. Yes, you need to meet the eligibility requirements. These requirements are the exact same as they were when you first joined the Men's Auxiliary. Eligibility for the VFW Auxiliary is Article XI section 1102. "Eligibility shall be limited to spouses, parents, grandparents, brothers, sisters, children and grandchildren of a person who was eligible for membership in the Veterans of Foreign Wars." Many members were allowed to join that were not eligible. What one needs to join the Auxiliary is a copy of the discharge papers, some form of proof

I am looking forward to continuing working with the VFW and the VFW Auxiliary now and in the future. I urge all eligible men that served in the Men's Auxiliary to become members of the VFW Auxiliary and continue on with the good works that you have done.

# "Here Comes the Judge" by Chad Solheid, State Judge Advocate

#### Section 218 a, 11 - Trustees

Greeting Comrades and Auxiliary members.

I would like to take this time to thank all of you that have supported me and mentored me over the years. I also want to thank all of the members that supported and elected to me to be the new State Judge Advocate. I am ready to continue the work that the many comrades that have gone before me have built. I will continue the mission.

I would like to start off by touching on one of the most important jobs in the VFW- the Trustees. The trustees are the overseers of the funds that are generated and dispersed throughout our department.

Sec. 218 ((a, (11)). Trustees) - Trustees shall not be eligible to serve as an elected office, adjutant, or on a committee whose books, records, and accounts are audited by the trustees. Among the duties of the Post trustees, they shall:

At least once a month, review the

monthly reports of receipts and expenditures of the post quartermaster.

Within (30) days from the end of each quarter, properly audit the books and records of the post quartermaster, post adjutant, and any activity, club room, holding company or unit sponsored, conducted or operated by, for or on behalf of the post and submit a post trustees report of audit to the department quartermaster for referral to the department inspector.

This By-Law is very important because if the trustees are doing their job every month it will be easier to find any mistakes or indiscretions. Posts that have Trustees that do not perform their duties find out the hard way that their funds are gone. The time it takes to find all of the missing funds could have been spent helping the very comrades that need our help.

So please Trustees do your due diligence in your duties.

I am so proud to be able to represent our State for all of the Brothers and Sisters of this great organization.



# **Claims and Service Officer Report**

#### Special Traumatic Brain Injury Review

I'm sure by now most of you have seen news stories regarding a KARE 11 investigation regarding Traumatic Brain Injury (TBI) claims in the State of Minnesota. In July of 2015 the Department of Veterans Affairs here in St. Paul, Minnesota had a meeting with all of the Veteran Service Organizations. At that time we were all dually notified that there had been a mistake in the way they were conducting TBI exams. The information received at that time was that they were going to be doing an administrative review of all TBI claims that were submitted from 2010 to 2014. At the time this amounted to 317 claims that were initially identified.

The reason behind the special administrative review was due to the fact that the Compensation and Pension Division had an unqualified individual who completed the exams. These exams are extensive and require special credentials. The regulation states that the exams must be completed by a neurologist, psychiatrist, physiatrist, or neurosurgeon. Unfortunately numerous exams were conducted by a certified nurse practitioner. This is obviously not in accordance with their rules and regulations, and prompted the exams.

In the beginning of August 2015, the DVA sent letters to numerous veterans notifying them that they had an initial TBI exam that was not performed by one of the necessary specialists. It further went on to explain that they were offering the veteran an opportunity to reopen their claim, and directed them to fill out the proper VA Form 21-526EZ to either request an increase or reopen their previous claim.

Prior to the veterans receiving this letter in August, your VFW Claims Office made a determination to be proactive for the 52 clients that we represented on this list, and were the only organization to do so. Directly after our meeting in July we received a list of individuals that we represent, and filed informal Intent to File Claims in order to save the date of claim. Your VFW As-sistant Director, Lynette Bonin, has taken this effort on with a full head of steam and has been an outstanding advocate for these veterans. At the time we were informed that the new date of claim would be the date for any increased or new rating. As it was through no fault of the veteran that their exams were performed by inadequate personnel, we were not satisfied but continued to work the issue. Shortly after filing the informal claims we followed up with formal claims for all of these individuals.

As we did not believe that it was advantageous for the veteran to have a date of claim that did not go back to the original date that they filed for TBI, it was the decision to try to obtain Equitable Relief to the Director of Compensation Service or Pension and Fiduciary (P&F) Service for one of the veterans who we represented. Equitable Relief is a remedy for an injustice done to a claimant resulting from mistakes made in applying rules and regulations that either deprived the claimant of benefits or caused the claimant to suffer a loss because he/she relied on an erroneous decision.

The reason we made this decision, which is not to be taken lightly, was in part to the VA already informing this gentleman that ne would receive a nearly \$30,000.00 back payment back to the original date of claim. Because of the anticipated award the veteran began paying off some debts, and they ceased operating his wife's private business. The VA then turned around later and stated that there was no guidance from the VA Central Office, they were sorry for their mistake and the veteran would only be receiving just over \$1,000.00 in back payments. We never did receive a determination regarding equitable relief for our veteran; however we believe that our efforts were the tip of the ice berg in regards what was to come from the Secretary of the Department of Veterans Affairs Robert McDonald. Minnesota was only the starting point to this injustice. Because of what was discovered in our state, there was a call from Congress and the Secretary of the Department of Veterans Affairs to audit all regional offices in the Nation. It was found that there was quite an astronomical amount of veterans across the US that experienced the same incorrect evaluations. It was further discovered that the claims only thought to have gone back to 2010, now are being reviewed back to 2007.

In June of 2016 Secretary of Veterans Affairs Robert McDonald granted equitable relief to nearly 24,000 veterans with TBI claims ranging from 2007 to 2015. What was stated at that time that they would be afforded new exams and that the VA was going to correct the injustice to the claimant where they are not otherwise authorized to do so within the scope of the law.

The reason why the VA is currently only looking at claims back as far as 2007 is due to the fact that the VA policy regarding specialists such as psychiatrists, physiatrists, neurosurgeons or neurologists was developed at that time. Their expertise is vital regarding the numerous complexities that come with TBIs. Since that same year medicine has been rapidly evolving, and the VA developed guidance regarding the necessity of specialists that may have been misconstrued at the time. However, that guidance is now clear and being followed.

Since the notifications that came out in August 2015, there have been new batches of veterans that have been notified. In July 2016 your VFW Claims Office received nearly 60 new notifications, and more trickle in every day. The new batches of notifications are trying to simplify the process for those who wish to re-entertain their TBI claims. It does let the veteran know that if they are willing to undergo a new TBI examination, they must notify the VA within one year of the date of the letter received. They are not requiring the veteran to file a formal claim on a VA form 21-526EZ. They are providing the veteran with a VA form 21-4138 Statement in Support of Claim sheet. They are asking the veteran to simply state the following on this form; "I am requesting reprocessing under VA's special TBI review.

Once again this office determined it necessary to be proactive regarding the veterans that we represent through the VFW. If we are dealing with individuals that potentially have some degree of cognitive impairment, and who may find the VA letter confusing, then it is our responsibility to ensure they are taken care of. We immediately referenced our new stack of veterans' letters and submitted requests on their behalf. We predict that more notifications are to come, and we will continue to be diligent with every one of them.

To date, because of the efforts of this office, we have procured nearly \$500,000.00 in retroactive payments for the veterans that we represent. We are not done, and continue to work closely with the VA and our counterparts to ensure that our veterans and all veterans dealing with this issue are compensated correctly for their injuries.

It is stated that TBIs are the signature injury in those veterans returning home from the wars in Iraq and Afghanistan. Based on new protective gear and advances in medical technology, we are seeing may troops today who survive injuries that our warriors of past did not. As advances continue to grow we will see great strides in protecting their quality of life and longevity.

If you are still wondering about the individual that I mentioned before and how his fight turned out, I am proud to announce that to date we have been able to procure him over \$55,000.00 in combined retroactive benefits. Because of the diligence of this office, and Lynette Bonin in particular, we know that his quality of life has improved and some financial burden has been lifted off of his shoulders. We are not done yet, and hope to see even more in his future to be able to provide for his family and live a life without financial worry. If any of you have any questions regarding your own TBI claims, or know of a friend or family member who might fall into this category, we urge you to reach out to our office. We will continue to fight the good fight in regards to these and all benefit matters, and hope that you can stand proud of your VFW Claims Office and our diligence and passion when representing our clientele.

#### VA Secretary Provides Relief for Veterans with Traumatic Brain Injuries

WASHINGTON, June 1, 2016 – Secretary of Veterans Affairs Robert McDonald has granted equitable relief to more than 24,000 Veterans following a national review of Traumatic Brain Injury (TBI) medical examinations conducted in connection with disability compensation claims processed between 2007 and 2015.

This action by the Secretary allows the Department of Veterans Affairs (VA) to offer new TBI examinations to Veterans whose initial examination for TBI was not conducted by one of four designated medical specialists and provides them with the opportunity to have their claims reprocessed. Equitable relief is a unique legal remedy that allows the Secretary to correct an injustice to a claimant where VA is not otherwise authorized to do so within the scope of the law.

"Traumatic Brain Injury is a signature injury in Veterans returning from the conflicts in Iraq and Afghanistan, and VA is proud to be an organization that sets the bar high for supporting these, and all, Veterans," said Secretary McDonald. "Providing support for Veterans suffering from a TBI is a priority and a privilege, and we must make certain they receive a just and fair rating for their disabilities." To ensure that TBI is prop-

To ensure that TBI is properly evaluated for disability compensation purposes, VA developed a policy in 2007 requiring that one of four specialists – a psychiatrist, physiatrist, neurosurgeon or neurologist – complete TBI exams when VA does not have a prior diagnosis.

Since 2007, medicine around TBI has been a rapidly evolving science. VA designated particular specialists to conduct initial TBI exams because they have the most experience with the symptoms and effects of TBI. As more research became available, VA issued a number of guidance documents that may have created confusion regarding the policy. VA has confirmed that its TBI policy guidance is now clear and being followed.

"We let these Veterans down," Secretary McDonald said. "That is why we are taking every step necessary to grant equitable relief to those affected to ensure they receive the full benefits to which they are entitled."

VA understands the importance of an accurate exam to support Veterans' disability claims. The Secretary's decision to grant relief will enable VA to take action on any new examinations without requiring Veterans to submit new claims. If additional benefits are due, VA will award an effective date as early as the date of the initial TBI claim.

VA will contact Veterans identified as part of this national TBI review to offer them an opportunity to receive a new examination and have their claims reprocessed. More than 13,000 of these affected Veterans are already receiving service-connected compensation benefits for TBI at a 10-percent disability evaluation or higher, which means that the diagnosis has already been established. of Veteran suicide rates in the U.S., examining over 55 million Veteran records from 1979 to 2014 from every state in the nation. The effort extends VA's knowledge from the previous report issued in 2010, which examined three million Veteran records from 20 states were available. Based on the data from 2010, VA estimated the number of Veteran deaths by suicide averaged 22 per day. The current analysis indicates that in 2014, an average of 20 Veterans a day died from suicide.

"One Veteran suicide is one too many, and this collaborative effort provides both updated and comprehensive data that allows us to make better informed decisions on how to prevent this national tragedy," said VA Under Secretary for Health, Dr. David J. Shulkin. "We as a nation must focus on bringing the number of Veteran suicides to zero."

The final report will be publicly released later this month. Key findings of the analysis will include:

- 65% of all Veterans who died from suicide in 2014 were 50 years of age or older.
- Veterans accounted for 18% of all deaths from suicide among U.S. adults. This is a decrease from 22% in 2010.
- Since 2001, U.S. adult civilian suicides increased 23%, while Veteran suicides increased 32% in the same time period. After controlling for age and gender, this makes the risk of suicide 21% greater for Veterans.
- Since 2001, the rate of suicide among US Veterans who use VA services increased by 8.8%, while the rate of suicide among Veterans who do not use VA services increased by 38.6%.
  - In the same time period, the rate of suicide among male Veterans who use VA services increased 11%, while the rate of suicide increased 35% among male Veterans who do not use VA services.
  - In the same time period, the rate of suicide among female Veterans who use VA services increased 4.6%, while the rate of suicide increased 98% among female Veterans who do not use VA services.

VA is aggressively undertaking a number of new measures to prevent suicide, including:

Ensuring same-day access for Veterans with urgent mental health needs at over 1,000 points of care by the end of calendar year 2016. In fiscal year 2015, more than 1.6 million Veterans received mental health treatment from VA, including at over 150 medical centers, 820 community-based outpatient clinics and 300 Vet Centers that provide readjustment counseling. Veterans also enter VA health care through the Veterans Crisis Line, VA staff on college and university campuses, or other outreach points.

Using predictive modeling to determine which Veterans may be at highest risk of suicide, so providers can intervene early. Veterans in the top 0.1% of risk, who have a 43-fold increased risk of death from suicide within a month, can be identified before clinical signs of suicide are evident in order to save lives before a crisis occurs.

## **Election Addition**

After 43 years of trying, we have finally succeeded in passing legislation this past session to repeal the unfair tax that military retirees have been paying on their retirement pay. Minnesota was one of the few states in the nation still taxing our retired military veterans who have served this nation for 20 years or longer. The Veterans of Foreign Wars Department of Minnesota has never given up fighting this unfair tax even when some thought it was hopeless. The State Commander's Task Force with Representative Bob Dettmer led the way in the house and with our membership support at Veteran's On the Hill Day we were able to succeed.

Our work is far from finished as I write this article; we still are waiting for the Governor to call a special session to pass a bonding bill. The State bonding bill contains funds for asset preservation at our Minneapolis State Veterans Home and the repair of the bridge over Minnehaha Creek. The bridge has been closed for years and is the only other access to the home for emergency equipment

This fall we all will have the chance to exercise our rights as American citizens and Veterans to take part in the election process. We need to get our message out to those seeking public office on every level national, state and local. Every Commander and District Officer needs to make our resources available this election, offering our Post homes to candidates for Town Hall meetings and Candidate Forums. Our National Organization is encouraging us to do so and has directed our State Departments to assist in any way we can. Contact the Department Office when you plan to host an event or have any questions and we will be happy to assist you with our resources.

Nationally, I will be attending our annual Legislative Conference in Washington, D.C. the week of September 12th, the day after our Fall Conference. We will be receiving our Priority Legislative Goals for the upcoming sessions and sharing them in personal meetings with the Minnesota Legislative Delegation.

The passing of the tax relief for Minnesota's retired military Veterans was not the only Veterans legislation passed this session; I have enclosed other Veteran related legislation and information on how to hold a Town Hall meeting or Candidate Forum.


#### **2016 Minnesota Legislative Session Recap -Veterans Related** Legislation

#### Ch. 189, HF 2749

<u>Summary</u>

The Omnibus Supplemental Budget bill included 12 provisions of interest to the Minnesota Department of Veterans Affairs, including \$845,000 worth of funding that will directly or indirectly benefit Veterans and their dependents through programs or studies, a major tax benefit to retired Veterans residing in the state, and policy initiatives including changes to the Veterans Preference Statute, Veteran-Owned small businesses, and a provision allowing for the creation of a Medal of Honor Memorial on the Capitol Grounds.

#### **Military Pension Tax Subtraction**



Members of a reserve component, the National Guard, Army National Guard or Air National guard who have performed or were credited for the required years of qualifying service

Eligible combat-related disabled uniformed services retirees

Members retired under 10 U.S.C. Chapter 61 - Retirement or Separation for Physical Disability

Individuals, including Surviving Spouses and/or Dependent Children, eligible for the federal Survivor Benefit Plan

The new subtraction for pension or other military retirement pay is effective for taxable years beginning after December 31, 2015.

#### **Appropriations and Programming**

Also included in this Omnibus bill are the following items of interest to Veterans:

\$50,000 (onetime appropriation) for AMPERS Veterans Voices programming (Public Broadcasting)

\$95,000 (onetime) for Veterans Voices (Minnesota Humanities Center)

\$100,000 (onetime) in rent subsidies for Veterans at Cottages of Anoka

\$200,000 (onetime) for "State Soldiers Assistance: Grants for Housing & Health Assistance"

\$150,000 (onetime) for Veterans Mental Health Study - Requires the Commissioner to study, quantify and describe unmet mental health needs among veterans

• \$250,000 (onetime) for "Disabled Veterans Interim Housing Study" - Requires the Commissioner to study the feasibility of partnering with a non-profit organization to provide interim housing for disabled veterans.

Minor changes to Veterans driver's license designation language - allow for pic-torial or symbol ("V") designation on DL's

Inclusion of Veteran-owned business in Minnesota Emerging Entrepreneur Board

Changes to state procurement contracts to certified Veteran-owned small businesses (Businesses which are majorityowned and operated by Veterans).

"The commissioner may award a contract for goods, services, or construction directly to a veteran-owned small business without going through a competitive solicitation process up to a total contract award value, including extension options, of \$25,000.

Language allowing MDVA to solicit donations for the Medal of Honor Memorial on the Capitol grounds.

Character development education curriculum in elementary, middle and high school programs incorporating the history and values of Medal of Honor recipients. **Changes to Veterans Preference** The following modifications were made to the Veterans Preference Act, Minnesota Statutes 2014, section 197.46: Increased parity in Veterans employed by county, home rule charter or statutory city, town, school district, or other municipality or political subdivision and state employed Veterans Hearing request changed from 60 to 30 days to request a hearing to contest a notice of dismissal Inclusion of the selection of an arbitrator from the MN Bureau of Mediation Services in place of a three-person panel. Important for those locations where no civil service board or commission or merit system authority exists The creation of a probationary period following initial hire (where Veteran is

not eligible for Vets Preference protections) in 'non-state government' political subdivisions

Language defining who pays costs and attorney's fees

"For disputes heard by a civil service board, commission or merit system authority, or an arbitrator, the governmental subdivisions shall bear all costs associated with the hearing but not including attorney fees for attorneys representing the veteran. If the veteran prevails in a dispute heard by a civil service board, commission or merit system authority, or an arbitrator and the hearing reverses the level of the alleged incompetency or misconduct requiring discharge, the governmental subdivision shall pay the veteran's reasonable attorney fees.

#### Ch.90, HF3252

Bill allowing certain military members, Veterans and their spouses to have the experience requirement for real estate broker's license waived, if the licenses were cancelled due to their service.

Veteran Suicide-A Call to Action summit. which focused on improving mental health care access for Veterans across the nation and increasing resources for the VA Suicide Prevention Program.

Suicide is an issue that affects all Americans. Recent Centers for Disease Control and Prevention (CDC) data reported in April 2016 that from 1999 through 2014 (the most recent year with data available from CDC), suicide rates increased 24 % in the general population for both males and females.

VA has implemented comprehensive, broad ranging suicide prevention initiatives, including a toll-free Veterans Crisis Line, placement of Suicide Prevention Coordinators at all VA Medical Centers and large outpatient facilities, and improvements in case management and tracking. Immediate help is available at www.VeteransCrisisLine.net or by calling the Crisis Line at 1-800-273-8255 (press 1) or texting 838255.

Included in the Supplemental Budget bill was the provision of a new income tax subtraction for military retirement pay. The new language amends Minnesota Statutes Chapter 290 which covers Income Taxes, specifically that Section defining items which shall be subtracted from federal taxable income. The language reads as follows:

*...to the extent included in federal taxable* income, compensation received from a pension or other retirement pay from the federal government for service in the military, as computed under United States Code, title 10, sections 1401 to 1414, 1447 to 1455, and *12733*.

Individuals, estates and trusts eligible for this subtraction from taxable income may include.

Members of active components of the armed forces who have performed the required years of qualifying service

Substance Abuse and Mental Health Services Administration, Department of Defense, National Institutes of Health) and new public-private partnerships (e.g., Johnson & Johnson Healthcare System, Bristol Myers Squibb Foundation, Walgreen's, and many more) focused on preventing suicide among Veterans.

Many of these efforts were catalyzed by VA's February 2016 Preventing






