You (the "Consignor") and DESIGN CONSIGN agree:

- The Consignor hereby warrants, represents and attests that they are at least 18 years of age, are the owner of all goods consigned and have the legal right to enter into this CONSIGNment Agreement.
- The consignment period for each Consigned Item will be 60 days from the date the item is presented to DESIGN CONSIGN (the "Consignment Period"). It is the responsibility of the Consignor to know when the Consignment Period expires on an item and the Consignor has a 30 day grace period during which they can pick up their items. Any unsold items which are not picked up within 30 days become the sole property of DESIGN CONSIGN.
- DESIGN CONSIGN reserves the right to determine the selling price of the Consigned items. Every effort will be made to fairly price items based on a number of factors including age, condition quality and market prices for comparable merchandise and to sell the item within the Consignment Period. The Consignor acknowledges that DESIGN CONSIGN is not a certified appraiser of antiques and/or collectibles.
- Consignor acknowledges that items may be discounted during the Consignment Period. Consignor agrees that Consigned Items may be displayed whenever and wherever DESIGN CONSIGN chooses.

- Consignor acknowledges that DESIGN CONSIGN will have a monetary investment
  in time, space and advertising consigned items and agrees that they will not
  remove Consigned Items prior to the end of the 60 day consignment period.
  Consignor agrees that in the event they remove an Consigned Item prior to the
  end of the Consignment Period they will pay a fee of 15% of the asking price or \$5,
  whichever is greater, plus any additional costs of the CONSIGNment, such as
  furniture pick up fees or any related selling costs.
- The Consignor will receive 50% of the final sales price of their Consigned Item, from which DESIGN CONSIGN will deduct any agreed upon charges related to pick up or preparing merchandise for sale.
- Consignors will be paid by check on a monthly basis for items sold in any month that their balance exceeds \$40. Checks will be issued within 10 days from the end of the month that the items were sold. Consignor balances can be used at any time toward purchases at DESIGN CONSIGN.
- All reasonable care will be taken to ensure the safety of items consigned with DESIGN CONSIGN, however, items are left at the consignor's risk. Consignor acknowledges that DESIGN CONSIGN is open to the public and is not responsible for any loss due to damage, theft or natural disaster.
- Consignor acknowledges that it is their responsibility to notify DESIGN CONSIGN of any change of contact information.
- The CONSIGNment Agreement will remain in force until canceled by either party and will cover all items delivered to DESIGN CONSIGN. Consignor acknowledges that DESIGN CONSIGN may from time to time make modifications to this CONSIGNment Agreement and notify Consignor by email.
