All temporary electrical installations shall comply with the law. All the materials used shall be in good conditions and bear the declaration of conformity as in D.M. 37/2008. All wirings and connections to the power grid shall be approved by the Hilton Sorrento Palace technical staff.

A copy of the declaration of conformity for all equipment and fixtures installed shall be submitted before the start of the event. Failure to do so will result in the default of the undersigned and the event will be cancelled and the contract will be terminated as of right.

All temporary metal fixtures supporting electrical and sound systems and appliances shall be grounded and provided with all the necessary documentation certifying their stability, bearing capacity and proper assembly.

A copy of the above technical documents shall be submitted before the start of the event. Failure to do so will result in the default of the undersigned and the vent will be cancelled and the contract will be terminated as of right.

In the conference centre rooms and areas:

- Equipment emitting harmful radiations is not permitted unless it is duly protected and in good conditions and bears the CE marking.
- Smoking is not allowed.
- > Using pieces of equipment and machinery that do not work properly is not permitted.
- All activities, demonstrations and shows that may cause risk of fire or any other danger for the public are not permitted.
- > Using free flames is forbidden unless duly authorised by Hilton Sorrento Palace technicians.
- Access of unauthorised people during fitting up and during the course of events is not allowed.
- Applying mirrors or glazed/glass surfaces that may mislead access to exit doors and ways is not permitted.
- All exit ways and doors and fire equipment stations shall be kept free of any encumbrances, even temporary.
- Any glazed/glass surface installed along exit ways shall be made of safety materials or structured so as to avoid collisions or so as they are not dangerous in case of breaking.
- > Entering materials that contain asbestos or cause lead exposure is not permitted.

- Using machinery and equipment that may cause harmful exposure to noise is not permitted unless a copy of the documentation certifying the compliance with the relevant regulations has been submitted.
- Storing and/or using hazardous substances and/or products bearing symbols Xn (harmful), T (toxic), O (oxidising), C (corrosive) is not permitted unless special safety procedures have been previously agreed upon with the Hilton Sorrento Palace representatives.
- All the materials used shall have reaction-to fire properties corresponding to the declaration of conformity herewith and no derogation is allowed.

- All combustible though not stuffed chairs and seats shall belong to a reaction-to-fire class not exceeding 2 [maximum European classes (A2-s1,d2) (A2-s2,d2) (A2-s3,d2) (B-s3,d0) (B-s3,d1) (B-s1,d2) (B-s2,d2) (B-s3,d2) (C-s1,d0) (C-s2,d0) (C-s1,d1) (C-s2,d1)];
- All external insulating materials shall belong to a reaction-to-fire class not exceeding 1 or 0-1, 1-0, 1-1 if the insulating element is non directly exposed to flames in case of fire [WALLS OR FLOORS maximum European classes (A2-s1,d0) (A2-s2,d0) (A2-s3,d0) (A2-s1,d1) (A2-s2,d1) (A2-s3,d1) (B-s1,d0) (B-s2,d0) (B-s1,d1) (B-s2,d1) -- CEILINGS maximum European classes (A2-s1,d0) (A2-s2,d0) (A2-s3,d0) (A2-s1,d1) (A2s2,d1) (A2-s3,d1) (B-s1,d0) (B-s2,d0)];
- All counter ceilings shall belong to a reaction-to-fire class not exceeding 1 [maximum European classes (A2-s1,d0) (A2-s2,d0) (A2-s3,d0) (A2-s1,d1) (A2-s2,d1) (A2-s3,d1) (B-s1,d0) (B-s2,d0)];

- All wall and floor wood coverings shall be duly treated with authorised paints of reaction-to-fire class 1 [wall maximum European classes (A2-s1,d0) (A2-s2,d0) (A2-s3,d0) (A2-s1,d1) (A2-s2,d1) (A2-s3,d1) (B-s1,d0) (B-s2,d0) (B-s1,d1) (B-s2,d1) -- CEILING maximum European classes (A2-s1,d0) (A2-s2,d0) (A2-s3,d0) (A2-s1,d1) (A2-s2,d1) (A2-s3,d1) (B-s1,d0) (B-s2,d0)], in compliance with the provisions as in I DM. 6 March 1992 (G. U. n°66 of 19/March/92);
- Only materials belonging to reaction-to-fire class not exceeding 1 [maximum European classes (A2-s1,d0) (A2-s2,d0) (A2-s3,d0) (A2-s1,d1) (A2-s2,d1) (A2-s3,d1) (B-s1,d0) (B-s2,d0) (B-s1,d1) (B-s2,d1)] shall be used to make any fixed or mobile scenes and backdrops.
