The Directory of Providers (Assessment/Training) is a directory listing companies who offer assessment and/or training leading to eligibility for test users to apply for the British Psychological Society's test user qualifications.

The Society's Psychological Testing Centre website is frequently the first point of call when someone is trying to find assessment/training providers.

It is a requirement that you nominate an Assessor(s), working at the company, whose assessment methods have been verified by the Society in order to subscribe to an annual entry on the Directory of Providers (Assessment/Training).
