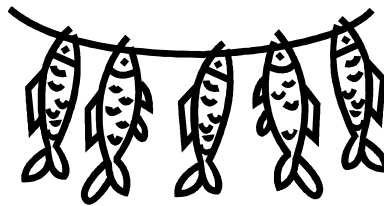
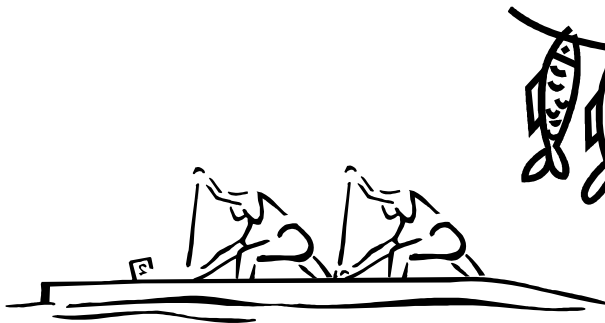
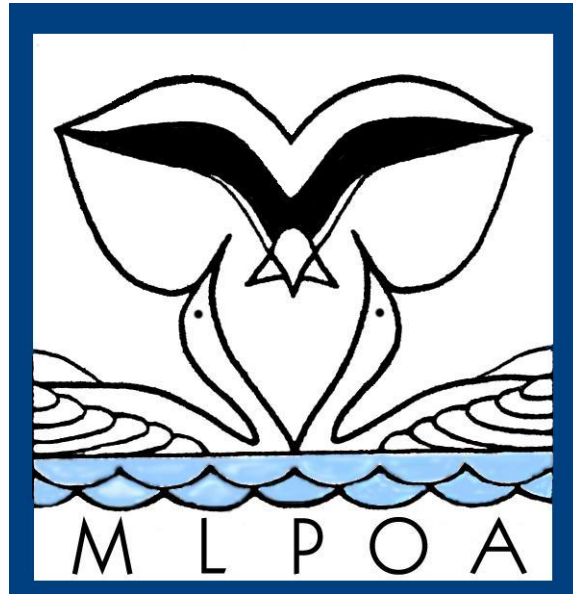

Summary of the 2012 Annual General Meeting

The 2012 Annual General Meeting of the MLPOA was called to order by President Don Berry at 9:05 am on Saturday August 11th at the Madoc Public Library.

Bob Hadley, filling in for Secretary Grant Ketcheson, read the minutes of the 2011 Annual General Meeting. Moved by Will Preston and seconded by Marty Lambert that the minutes of the 2011 AGM be adopted as read. Carried

Business arising from the 2011 minutes included the following:

- Based on Member requests for information on species at risk (turtles in particular) Bob noted that photos and descriptions were included in the annual newsletter this year, but haven't been put onto the website yet.
- It was noted that the 3rd annual golf tournament was a success, and \$1,800.00 was raised for Food for Learning. Appreciation was expressed to Glenn Sidsworth for coordinating the event.

- As a follow-up to the discussion in 2011 on garbage bins and dumping on the private lanes, Bob Hadley reported that he had obtained the letters sent by the Municipality for those identified dumping. It was suggested that these letters are not worded strongly enough and make no reference to the bylaw and possible fines to be imposed. Bob also reported that the Municipal CAO/Clerk has informed Council that she hopes to have permission before the end of August to be able to search the vehicle registry if offenders are seen and their license numbers are reported. This capability was not in place previously, even though many members were told to take down and report license numbers. At this point the Municipal CAO/Clerk has not been asked to change the letters to offenders, but the changes will be discussed in the near future.

President Don Berry then called on Reeve Owen Ketcheson who brought greetings from the Municipality of Centre Hastings. Reeve Ketcheson provided information on the average house assessment in our municipality, \$173,000.00, with tax increases expected to be 1.89%. Municipal budgets for roads, fire, garbage pick-up, landfill and recreation were all brought to our attention. The new recycling bins which were placed at several locations on the lake last year have been successful. They cost approx. \$3,000 each and there is a 25% grant available for purchasing the bins, but there are no plans to expand the program at present. The Reeve also noted the cost of garbage trucks and the fact that the municipal truck is over 14 years old and is in need of replacing. Contracting out that service is also an option for consideration. Reeve Ketcheson stated that an employee salary review is underway with comparisons to surrounding municipalities. In terms of economic development the Reeve reported an increase of 3.02% over last year in "new builds". The municipality has knowledge of 2 planned sub-divisions, plus the McDonalds Restaurant along Hwy#7 and renovations to the Foodland grocery store. The Reeve had no knowledge of a possible Canadian Tire Store on Bonjour Blvd, which has been rumoured for some time. Reeve Ketcheson thanked everyone for the success of the Centre Hastings Annual Regatta and advised all that he appreciated and welcomed input from all individuals as well as associations such as the MLPOA.

Boat Launch Revitalization Committee Chair Tom Simpson reported on the boat launch project. The project has experienced some delays in obtaining permits, but is still expected to be completed in 2014. Funding of approximately \$86,000.00 has been obtained. In addition to the parking lot and boat launch improvements, there will be new washrooms and change rooms constructed and an educational boardwalk. Mr. Simpson thanked the MLPOA for their commitment to the Boat Launch Project.

A brief Treasurers report was given by Dana Gawley. It was noted that revenue to date for 2012 is \$3,920.00 with expenses of \$1,182.99. The MLPOA has a 5 year term deposit for \$5,000.00 that is coming due in December 2012. The proposed budget for 2013 was read.

It was moved by Harry Quart, seconded by Glenn Sidsworth, that the MLPOA allocate \$500 in the 2013 budget to the Centre Hastings Annual Regatta. Carried.

Mr. Glenn Sidsworth proposed the idea of a \$50.00 "kick back" for all zones which achieve "full membership." The idea is being entertained but needs further consideration to determine how to fairly administer the funds.

It was recommended by Dana Gawley to keep the membership fee at \$20.00 for the 2013 year. Moved by Kathy Quart and seconded by Tracy Thompson. Carried.

Moved by Kevin McLaughlin, seconded by Glenn Sidsworth, to accept the 2013 budget as amended to include the expenditure of \$500 for the 2013 Centre Hastings Regatta. Carried.

Moved by Andy Sherwin and seconded by Kevin McLaughlin to reinvest the \$5,000 GIC principle and put the interest accrued (estimated at \$813) into the operating account of the Association. Carried

Bob Hadley reported on Operations and thanked Zone Rep's for all their hard work this year and for their collections. Membership updates have been received for all but 1 zone and we have 218 paid up members, 49 members overdue for renewal and 26 lapsed members not renewed. We currently have 20 new members. Based on an estimate of 320 properties around the lake we have a 70% participation rate. It was reported that volunteers are needed for the following positions:

- Zone Reps for Zones 2, 3 and 11.
- Communication Chair for newsletter and web site monitoring.
- Vice President / Director

There was a brief discussion regarding the MLPOA Constitution and the reporting relationship of Committees. The previous Executive had established that Committees reported to the Vice-President, but that protocol was never brought forward as an amendment to the Constitution. The current Executive would need to bring this amendment forward to the membership at the 2013 AGM if that change is to be made.

President Don Berry then called upon Lake Steward Jim Beatty who reported that the average flow of the lagoon in 2011 was 776 m³ / day and all discharge was within allowable limits. Weed harvesting started on the 16th of July and consisted of 36 Private areas and 8 common areas. The 2nd cut is scheduled to begin on the 15th of August with 25 private cuts and 8 common areas. Jim reported that we will have to refuse to harvest weeds from severely rocky areas as the most recent repair from such damage was \$4,500.00.

Jim reminded Members that the lake is extremely low this year and that buoys are placed by the MLPOA on a "best efforts" basis, but the MLPOA holds no responsibility for boat or motor damage. Buoys move and people take them, so please give extra care and an extra wide berth when near a buoy. Signs are being posted in regards to limited liability by the MLPOA. Also new speed limit signs were posted on the trestle bridge.

Kevin McLaughlin gave a short report on the Road Gravel Matching Program. Kevin needs to receive all receipts for gravel by Labour Day Weekend. Bob Hadley suggested that a request could be made to the Municipality that the current \$5000.00 budget be increased to \$10,000.00 and include more services other than just gravel, i.e. maintenance, snow ploughing, brush trimming, culverts, etc. Kevin has asked all Road Stewards to produce copies of their receipts for such expenses to help build a better case to the Municipality for the expansion of this program.

Kathy Quart asked if it is possible to obtain a written report from the Fire Department to determine what improvements need to be made to the private roads for them to be deemed accessible to emergency vehicles. It was reported by Don Berry that in 2011 a report was given and all roads were within limits.

Glenn Sidsworth asked how the gravel matching funds were allocated back out to the private roads. It was stated that there was "No Perfect Formula," but those who purchased more gravel received more \$\$ back, based on a percentage formula. The program is open to ideas and suggestions on how to allocate the funds.

Reeve Ketcheson thanked the roads committee for their contribution towards keeping the roads clear and maintained.

Andy Sherwin gave a short synopsis on the MLPOA Web Site. Better use of the current program is being made; currently we have 145 e-mail addresses in the system. Using e-mail helps lower the cost of communication. The current web site is receiving a few hundred hits per week and the billing has been switched from monthly to annually to reduce costs by 10%.

Peter Sparring and Dave Little from O'Hara's Mill came and gave a wonderful presentation on the Homestead. Great thanks to both gentlemen for volunteering their time. \$135.00 in donations was given to O'Hara's Mill.

Lake Steward Report

Following an exceptionally low water season in 2012, where Level 2 Low Water Alerts were issued in several watersheds in the area and a Level 3 Alert was barely averted, the weather this winter brought closer to normal amounts of snow and lake levels are currently normal for this time of year.

The 3rd Annual Moira Lake Ice Fishing Derby was held on the Family Day weekend in February. This event, coordinated by Brad McNevin and Tadam Neuman, drew over 300 registered participants and raised about \$3,500 for the Heart of Hastings Hospice. Once again the MLPOA provided a trophy to the winner of the Largest Fish (Youth Division) category. Congratulations to Logan Prevost who won the trophy this year.

Water Testing – Testing in the lake is conducted by several government and quasi-government bodies throughout the year. Early in the Spring and late in the Fall the municipal sewage lagoons are discharged into Deer Creek and through the lake. This activity is closely monitored and the test results show that the levels of contaminants in the discharge are very low and much below the permitted safe levels. Nevertheless, the MLPOA continues to voice concerns that the nutrient value (nitrogen, phosphorous, etc.) in the discharge does promote weed growth in the lake. Quinte Conservation Authority also tests the water in the lake at several sites, including the public beach, throughout the summer months to ensure that the water quality is suitable for swimming etc.

Buoys – Boaters are reminded that buoys are placed on a “best efforts” basis by the MLPOA as a guide to known hazards. However, it is the responsibility of boaters to be aware that there may be unmarked rocks or shoals in the lake and to govern themselves accordingly.

Fishing Regulation Changes – Open Season for Walleye (Pickerel) and Pike starts the 2nd Saturday in May, Muskie starts the 1st Saturday in June and Bass (Largemouth and Smallmouth) starts the 3rd Saturday in June. This is a change of bass season opening by one week due to earlier spawning seasons. Walleye regulations now include a slot size limit. All walleye legal kept must be between 40 and 50 centimeters (15.7 to 19.7 inches).

REMEMBER - IT IS ILLEGAL TO ATTEMPT TO CATCH FISH FOR WHICH THE SEASON IS CLOSED, EVEN IF YOU ARE GOING TO RELEASE THEM.

Weed Harvesting – In 2012 “public area” cuts were made at the Kiwanis Beach (boat launch), the Moira River inlet and outlet, Reynolds Landing, Deer Creek inlet and the culvert under Highway 62 to maintain water flow through the lake and keep the beach area clean for swimmers. 81 “private” cuts were made, with 13 properties opting for 3 cuts each, 12 opting for 2 cuts each and 18 properties opting for the single cut option. Once again this program operated at very close to “break even” as far as cost to the municipality for the maintenance of the public areas.

This service will continue in 2013 with harvesting of both public and private areas starting after the permitted date of July 1st. For your convenience an application form is contained in this newsletter. Please complete all of the information and ensure that you follow all instructions with respect to marking your property. Harvesting of private areas must not exceed 100 square yards (about 30 x 30 feet). The idea behind this is to allow people to have cleared areas for recreational swimming and for getting boats out into deeper water.

The cost for 2013 remains \$90.00 for a single cut, \$170 for two cuts, or \$250 for three cuts, if paid in advance.

Operations Officer Report

In 2012 the Association continued to have great membership numbers, with 231 paid memberships, but struggled with keeping Executive positions filled. E-mail addresses were updated for some of our Members, but we still have only about 145 e-mail addresses and this year demonstrated how important this communication vehicle can be. During the municipal budget debate we informed Members via e-mail of the plans to cancel the Road Gravel Matching Program, and over 100 Members e-mailed their concerns directly to members of Council.

A letter was sent to all Members regarding our future direction and the need for volunteer support at the Executive level. The responses were very encouraging in terms of the ongoing need for the MLPOA to perform its “core” mandate with respect to road gravel, weed harvesting and water quality issues. Unfortunately we also had too many of these letters returned to us, indicating that our Member address information was out of date and needs to be refreshed.

2013 MLPOA Annual General Meeting (AGM)

The 2013 AGM will be held on **Saturday, August 10th** in the basement of the Madoc Public Library, starting at **9:00 AM**. The library is located at 20 Davidson Street, next to the Post Office. Parking is available on the street, beside the library and behind the library in the Tri-Area Medical Centre parking lot. **THIS IS AN ELECTION YEAR**, so please come out to the meeting and ensure that we have a leadership team in place to support the future of the Association.

Road Gravel Matching Program Cancelled

By now most MLPOA Members will have heard that the Municipality of Centre Hastings Council decided during the 2013 budget deliberations, by a vote of 3/2, to cancel the Road Gravel Matching Program. This program had been providing up to \$5,000 per year to match purchases of gravel made by residents living on private right of way access "lanes". It was initiated in 2007 to recognize the fact that owners of lakeside properties pay higher taxes due to the assessment of waterfront property, but receive fewer services (notably road maintenance and snow removal) due to the "Limited Service Residential" zoning designation. It also took into account the fact that maintenance of the roads is essential to provide safe passage for emergency vehicles, including fire and ambulance. Despite arguments presented by the MLPOA and more than 100 e-mails sent by property owners to the Council, they yielded to the Centre Hastings Ratepayers Association which has targeted this program every year since the 2010 municipal election.

Weed Harvesting – Private Shorelines

Weed harvesting will be available along private shorelines from mid-July in accordance with permits received. **You may pre-book a single cut for \$90.00, two cuts for \$170.00 or three cuts for \$250.00.** Please remember, we are only permitted to harvest 100 square metres (about 30 x 30 feet) on each cut. **An application form is included in this newsletter.**

Payment must be made by July 1st. Please make your cheque payable to "The Municipality of Centre Hastings – Weed Harvesting". Mail or deliver your cheque to: The Municipality of Centre Hastings, 7 Furnace Street, PO Box 900, Madoc, Ontario, K0K 2K0, Attention: Treasurer.

It is **important** that you physically identify the property/area to be harvested to allow the harvester operator to identify the correct location. Please place either a permanent or temporary sign showing your Lane Name and 911 #, **visible from Lakeside**, directing the operator to the area to be harvested. If you have any submerged water intake lines or pumps please mark their location with a float to avoid having them damaged by the harvester.

Lakeside "911"

Emergencies can happen anytime, anywhere, including boating accidents or a fire onshore being spotted by a passing boater. The Municipality of Centre Hastings Emergency Preparedness Coordinator advises that posting of 911 addresses at lakeside could help identify the location of an emergency more accurately so that emergency services (fire, ambulance, police, etc.) can get to the emergency more quickly. Please consider posting your 911 address visible from the lakeside as an aid to emergency response.

Waterfront Property Owner Resources

Looking for information about septic system or well maintenance; want to know what you can and cannot do to preserve and protect your shoreline? MLPOA, in cooperation with Quinte Conservation Authority, can provide you with a wealth of resources specifically geared to the waterfront property owner. These resources, from both federal and provincial government departments and agencies, are being provided to you through the Quinte Conservation Authority. Moira Lake / Kiwanis Beach Rejuvenation Project

Many local residents and tourists have seen a great deal of activity going on at the free public access/use beach area on Moira Lake this Spring. The work is the first visible phase of the project after all the hours spent behind the scenes on grant applications and in other fund raising endeavours.

Prior to the ice melting on the lake this year, the old concrete boat launch pad was completely removed and a new greatly improved pad was installed. At the same time the existing pier was modernized, with new sides and cement cap. This was done to have the site ready for boaters when the fishing season opens in May.

The next phase has been the installation of new septic tanks and the construction of new washrooms and change facilities. The construction work has been performed by the High School Renovation and Restoration program students, with completion of the work scheduled before the influx of beach and lake users.

Ontario Ministry of Transportation agreement and funding has now been finalized for a new access road to the site, greatly improving vehicular and pedestrian traffic safety. This will see a new entrance being constructed close to the south end of the new Educational Boardwalk, which was financed through the Madoc Chapter of Ducks Unlimited and committee fundraising. The boardwalk was constructed last Fall by Ducks Unlimited volunteers and students from Centre Hastings High School. An expanded parking lot will be created to provide relief to the oftentimes overflowing parking lot near the boat launch ramp.

The volunteer committee members who have been working on this major project are very excited by the results in having raised \$ 123,000, and are anxious to receive added public support as steps continue to make the entire beach and boat launch area something all rural and urban residents, cottagers and tourists can take pride in. The improvements all stem from public consultation; with the need remaining to fund wheel chair accessibility pathways, picnic benches, solar lights, recreational equipment, and landscaping; all amounting to \$ 50,000.

Summary of Centre Hastings Fire By-law 2006-20

During the period from April 1st to October 31st no fire for the burning of grass, rubbish, wood or other combustible material shall be permitted outdoors between the hours of 7:00 am – 7:00 pm, except for the following:

- Fire for cooking or warmth
- A small fire no more than 1x1 meter attended at all times by an adult
- A fire in a metal container covered by a metal mesh ¼ inch in size

Please note: Fire risk conditions vary throughout the year and you are expected to follow all fire bans or other restrictions as they arise. Please check the Centre Hastings website at www.centrehastings.com for the latest fire hazard assessment.

Garbage Bin and Recycling Stations

Centre Hastings is one of a few municipalities that provide garbage and recycling stations on lanes serving waterfront properties. In order to maintain this service, please note the following:

Only non-recyclable household waste contained in CLEAR PLASTIC BAGS is to be placed in garbage bins. You are permitted to use an opaque bag within the clear bag for personal waste such as medical waste.

Recycling bins (other than those lanes with the large trial bins) are for recyclable waste only in the following categories:

Paper and fibres: includes newspapers, cardboard milk or juice containers, plastic bags, cardboard boxes (broken down to fit in the blue box), any other paper or soft plastic fibre.

Containers: includes plastic bottles (water or pop), aluminum cans (beer, pop, etc.), plastic water jugs, plastic containers from groceries, metal cans (soup, beans, tuna, salmon, etc.),

Glass: Depends – if your site has a separate glass receptacle, then glass goes into this receptacle and not the blue boxes. **DO NOT PLACE GLASS IN BLUE BINS NOT DESIGNATED FOR GLASS. IF YOU DO, THEY WILL NOT BE PICKED UP AND SOMEONE ELSE (one of your neighbours) WILL BE CLEANING UP YOUR MESS FOR YOU.**

All non-collectable material is NOT to be left at these garbage and recycling stations, but MUST be taken to the municipal landfill/recycling site.

Landfill Site

The Municipality of Centre Hastings Landfill Site and recycling station is located at 106968 Highway #7 East, 4.5km East of the intersection of Highways #7 and #62. Their phone number is 613-473-4581 and the summer hours of operation are: **Monday 9:00 – 3:00; Wednesday 9:00 – 3:00; and Saturday 8:00 – 4:00.** Please use the landfill site and do not dump non-collectable material at your lake bins for others to clean up.

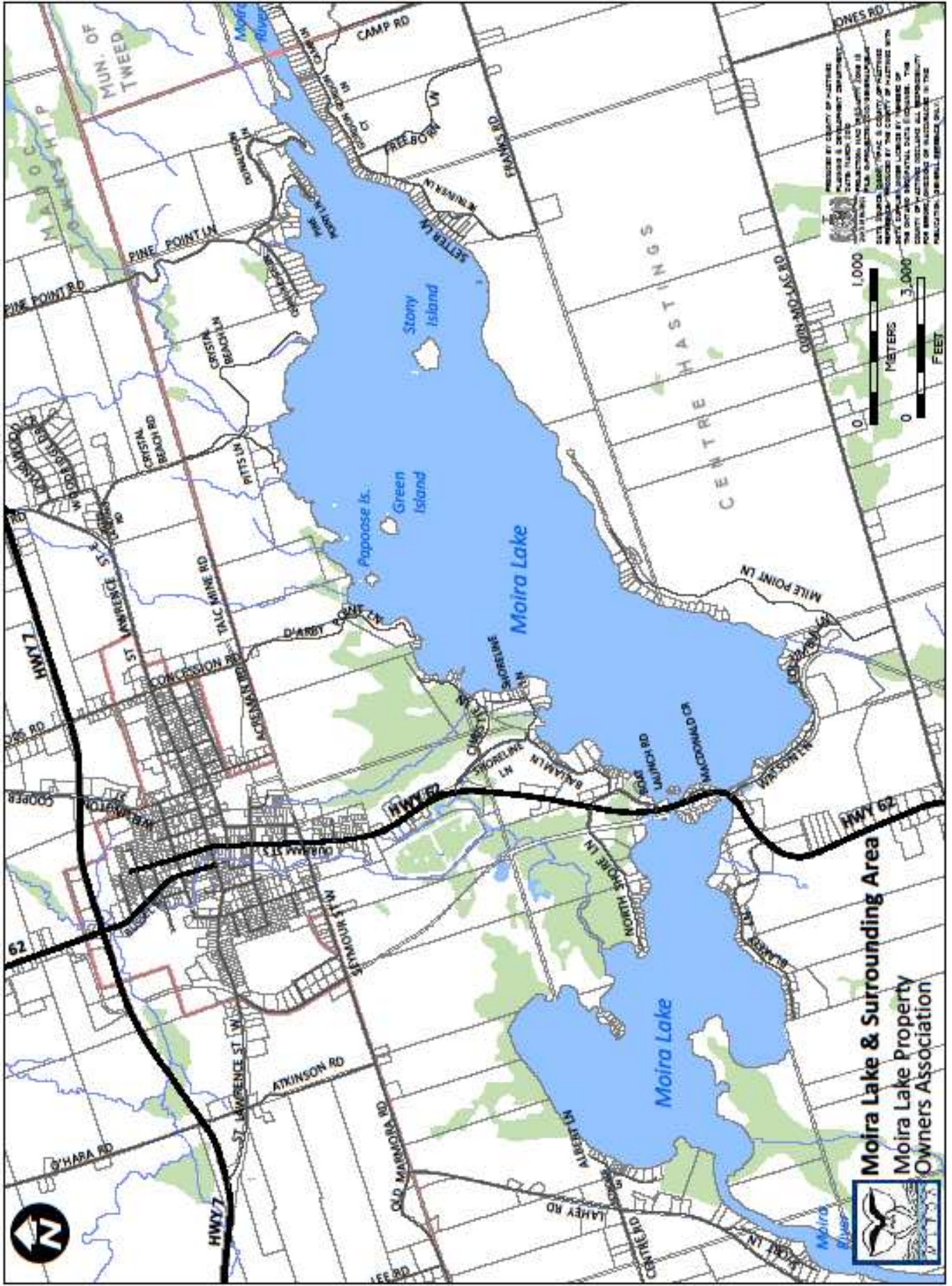
