Animal Microchipping

Queensland legislation requires all dogs and cats born after 1 July 2009 to be microchipped by three (3) months of age.

All dogs and cats given away or sold must be microchipped at point of sale or transfer to a new owner.

If you have purchased or been given a dog or cat, it is your responsibility to ensure it is microchipped.

Council provides a microchipping service for dogs and cats for \$25.00 per animal. Contact the Animal Shelter on (07) 3829 8663 to make an appointment

Wandering Cats

Cats are popular pets in the Redlands. We wish to encourage responsible pet ownership, effectively manage cats and enhance community safety. To protect our local wildlife, cats are to be confined to the property at all times and inside the house or enclosure.

Properties Where Animals Not Permitted

Some areas of the Redlands have a lot of natural wildlife and keeping of domestic animals can have an effect on wildlife populations. The only area in the Redlands where cats are not permitted to be kept by residents is Ridgewood Downs in Mount Cotton.

If you live in a unit, townhouse, caravan park or aged care facility you should seek approval from the body corporate or management before obtaining an animal.

Barking Dogs

Sometimes, a neighbourhood dispute over a dog's excessive barking can be settled by speaking to its owner.

The dog's barking may be occurring when its owners are absent, so they may be unaware of the problem.

If approaching your neighbour and explaining the problem doesn't lead to a solution, there are other courses of action you can take.

If the problem persists, lodge a complaint with Council and a letter will be sent to the owner.

Council's Local Law 2 (*Animal Management*) allows Council to take action against an owner if an animal causes an unlawful environmental nuisance.

The noise emission criteria is defined as noise which exceeds six minutes in any hour from 7am to 10pm on any day; or the noise exceeds three (3) minutes in any thirty (30) minute period after 10pm or before 7am.

Off Leash Areas

There are thirty (30) dog off-leash areas in the Redlands. Most of the sites are clearly signed and fully fenced. Dog bag dispensers are provided in all areas, apart from North Stradbroke Island. These sites are a great place for dogs to run free but you need to have control over your dog at all times while using the off leash areas.

Dog owners caught letting their dogs play off-leash in non-designated off-leash areas will get an on-the-spot fine under Council's Local Law No. 2 (*Animal Management*).

Third Animal Permit

Council's Local Law 2 (*Animal Management*) restricts residents from owning more than two (2) dogs and two (2) cats per property. If you want to own a third dog or cat you will have to apply for a permit. Permits may be granted for applicants if a strong compassionate reason exists.

Lost and Found

Council runs an Animal Shelter for lost or stray animals within the city.

When an animal is brought to the shelter, Council contacts the registered owner to collect it. All cats and dogs over three (3) months old must be registered with Council. Registered dogs are kept for seven (7) days, unregistered dogs for three (3) days and cats for five (5) days. After this time, animals are sent to the RSPCA.

When collecting an animal from the shelter, release fees are charged.
