The Renter agrees that the equipment herein shall be delivered and returned by the Renter at his own risk, cost and expense to Finalé Post Production Inc., dba Finalé Editworks and/or EMedia Digital Solutions (Finale). Acceptance by Finalé of the return of the rented equipment shall not constitute a waiver by Finalé of any claim it may have against the Renter under this Agreement or for latent or apparent damages to the equipment.

l(the "Indemnities")

Finalé makes no representation about the suitability of the equipment for the use intended by the Renter. The Renter acknowledges that he has examined and tested the described equipment and received the equipment in good mechanical and working condition, and hereby agrees that he will hold harmless Finalé, its affiliated companies, employees and agents against all loss arising from damage to film data, videotape, or delay in filming or production, arising or alleged to have arisen out of the performance or non performance of the equipment or its suitability for use, and will waive all rights of subrogation against them.

The Renter agrees to pay Finale the rental charge for the supply and use of the equipment listed, for the designated rental period at the standard daily rate plus all applicable taxes. Special rates apply only if agreed to at the time of the rental. The Renter agrees that Finalé shall not be responsible for any delay or losses the Renter may encounter during the rental period, due to weather, equipment malfunction or any reason whatsoever

The Renter shall indemnify and hold harmless Finalé, its affiliated companies, employees and agents against all losses, claims, expenses, costs or damages arising directly or indirectly from the rental, use, operation or handling of the equipment. This shall include, but not limited to, sums claimed for bodily injury, personal injury, property damage, loss of income and financial loss howsoever caused, and any and all costs incurred in the defense of such claims or actions. The Renter hereby waives all rights of subrogation or recovery against Finalé, its affiliated companies, employees or agents

The Renter further agrees to compensate Finalé in rent for any time lost as a result of replacement or need for making repairs on rented equipment. The Renter agrees not to loan, sublet, mortgage, sell, or dispose of this equipment in any manner. The rental equipment shall remain at all times under the immediate control, supervision and direction of the Renter, and will not becovered by insurance for theft or loss from an unalarmed vehicle.

In the event that the Renter fails to maintain insurance as specified above, the Renter hereby agrees to be fully responsible to compensate Finalé for full replacement value, parts, repairs and labor thereto plus all applicable taxes should the said rental equipment be lost, stolen, missing, broken, damaged and any cause whatsoever whether or not due to the fault of the Renter, orcovered by the abovementioned insurance.

All rental equipment must be returned no later than 9:00 am on the day following the end of the rental period, unless otherwise agreed and the Renter agrees to pay the normal rate for each additional day the equipment is not returned by the due date and time.

The Renter agrees that facsimile copies hereof shall be treated as originals, fully binding and with full legal force and effect, and hereby waive any rights they may have to object to said treatment. All charges made to a credit card/charge card and/or payments made from a bank debit card card for the Rental Agreement and or security deposit are fully authorized and Renter agrees to resolve all disputes with Finalé as if they were made as cash payments. Renter and/or cardholder waive any rights to dispute charges with the credit card company and or banking institution.

The Renter agrees that a cancellation fee of 50% of the full rental value will apply against a confirmed order and against orders cancelled with less than 24 hours notice.

The Renter agrees that acceptance of the equipment shall be considered acceptance of the above conditions of rental.
