Venue Rental Fee:

- A. Lessee agrees to pay \$2500.00 plus 7.5% sales tax for the use of the facility on the date and time outlined above.
- B. Lessee understands that a 50% deposit is due on the date this contact is executed and payment in full is due 60 days prior to the event.
- C. Lessee acknowledges that should the need to cancel this agreement arise, they will forfeit their 50% deposit unless Lessor finds a new Lessee for the same time period. Furthermore, should the need to cancel the venue arise within 60 days of the event, Lessee will forfeit 100% of the fee unless the Lessor can find a new Lessee for the same time period.

Usage Guidelines:

- A. Lessee understands and agrees that an approved wedding planner must be obtained for the event
- B. Lessee understands and agrees that only approved vendors will be allowed to participate.
- C. Lessee understands and agrees to abide by all policies outlined as established by the Forest Street Homeowners Association.
- D. Lessee acknowledges that failure to strictly comply with all requirements can result in fines up to \$500.00 per occurrence.
- E. Lessee acknowledges that any intentional damage to the park will be the sole responsibility of the Lessee via the credit card authorization on file.
- F. Lessee acknowledges that parking in the Seaside community is limited and that all events must come with a parking plan appropriate for the number of expected guests and approved by HOCO at least two weeks prior to the event.
- G. Lessee will hold harmless Lessor, the Forrest Street Owners Association, and their affiliates and agents for any claims resulting from the use of the park facility.

Lessor Responsibilities:

- A. HOCO will be responsible to ensure that proper cleaning/trash removal is performed before and after the event.
- B. HOCO will have a representative on site before, after, and during the event to assist with any last minute needs requested by Lessee.
- C. Upon request, HOCO will provide Lessee with a list of recommended service providers to assist in planning and coordination needs.
