## **POOL "POINTERS"**

PSMRA Members, their guests and tenants are free to enjoy all four (4) pools and SPA's as well the restrooms, bars, chairs, tables, and barbeque grills located on pool grounds. A resident must always accompany guests and is responsible for the behavior of everyone in their party.

- Monte Pool east side of 48<sup>th</sup> Street at Monte Way. Parking lot entrance on Monte Way.
- Euclid Pool east side of 48th Street north of Euclid Avenue. Parking lot entrance on Euclid.
- Siesta Pool 5015 East Siesta Drive, just off Hazel Drive. Street parking.
- Vantage Pool 48<sup>th</sup> Street north of Caldwell Street, west of Traffic Control Gate near Rustler's Roost.

**KEYS:** The same key operates all pool gates and restrooms. All gates to be kept closed and locked at all times.

- Do not prop open any gate
- Do not permit anyone without key to enter, or climb the fence.

**HEALTH and SAFETY RULES**: Owners, residents, tenants, guests (and trespassers) use all pool areas at their own risk. An adult must accompany and supervise children under age fourteen (14). Children under age twelve (12) are not permitted to use the SPA at any time. Pools and spas must be evacuated during lightning, thunder, or any severe weather.

- The Association provides NO LIFEGUARDS. Emergency equipment such as life rings and shepherd crooks may not be used as pool toys.
- NO DIVING pools and spas are shallow water.

Alternate Mailing Address

- NO GLASS is permitted in any pool area at any time.
- NO PETS, bicycles, skates or skateboards are permitted in any pool area at any time
- NO RUNNING, canon-balling or horseplay permitted
- Persons with health risks should consult their physician before using the SPA or pool and be considerate of others. Babies/toddlers must wear swim diapers.
- Refrain from playing loud music, smoking, using floats, rafts, balls, Frisbees that could interfere with others' safety or enjoyment of the pool.
- Please cleanup before leaving and report any vandalism to Management Company.
- The Association may suspend pool privileges for violations of pool rules or failure to pay assessments.
