### **History and Rationale**

At the September 2010 meeting of the Presbytery, we approved a \$25,000 loan from the Foundation for Milwaukee, Christ. The loan is for three years. The first year is interest free. The remaining two years the loan will have an annual interest rate of 2.25%. Milwaukee, Christ was not able to repair the church parking lot in the fall because they were not able to get the city permits necessary to do the repair. The permits have been procured from the city and Milwaukee, Christ will repair the lot in the spring of 2011. Milwaukee, Christ has not requested the \$25,000 and will not until they require the money sometime in the spring of 2011.

### Financial Condition of Presbytery:

The cash balance on 12/31/2010 was \$139,990 which is a increase of \$29,281 since 01/01/2010. The cash balance on 12/31/2009 was \$110,709. Total operating income this year is \$530,944 compared with \$532,674 last year. The decrease of \$1,730 from last year is because of an increase in foundation income and decrease in per capita and mission. Total expenses this year are \$523,206 compared with \$508,657 last year. Expenses have increased \$14,549 because of increased spending in all areas except Mission Partnerships, Council, Administrative and per capita. The surplus for the year is \$7,739 compared to a surplus of \$24,017 last year, mainly because of revenues being lower in 2010. The expenses of the Presbytery were at 96% of the budgeted amount for the year.

### Public Witness director says political power is found at grass-roots level

Calling Washington, D.C., a "seductive environment," J. Herbert Nelson,


director of the Office of Public Witness of the Presbyterian Church (U.S.A.), said, "You can become enamored with that environment."

And Nelson makes sure he spends time away from his office in the capital because he believes that political power rests on the local level.

Nelson spoke Monday evening during the winter meeting of the Synod of Lakes and Prairies.

"Our work is not just speaking truth to power; it is discipleship," he said. He said the church needs to be "leading biblically, speaking theologically and acting faithfully."

Nelson does that by promoting political advocacy through the church away from the nation's capital – an advocacy that must come from the local, grass-roots level. Such advocacy,



he believes, can lead to solutions to the complex problems faced by the nation.

### Presbyterian Homes moves forward under 5-year strategic plan



Presbyterian Homes and Services is following a new fiveyear strategic plan and Dan Lindh, president of the Roseville, Minn.,-headquartered services organization, spoke about the plan Jan. 17 at the winter meeting of the Synod and Lakes and Prairies.

Leading an organization ranked as the nation's fourth-largest not-for-profit service provider of services to the aging by the respected "AAHSA-Ziegler 100" report, Lindh said PHS currently serves approximately 17,800 older adults each year, including 12,000 "under our roofs" in 6,096 units, and 5,800 in the community. PHS has facilities located in Minnesota, Wisconsin and Lowa

Highlighting the organization's five-year plan, Lindh said the plan includes seven initiatives: (1) structure and leadership, (2) home- and community-based services, (3) development of a second geographic area, (4) traditional

### SDOP Committee funds 3 projects

The Synod of Lakes and Prairies' Self Development of People Committee announced three grants totaling \$50,000 to three organizations in the presbyteries of Northern Plains and Twin Cities Area.

The committee awarded a grant of \$25,000 to the International Market of the Immigrant Development Center in Moorhead, Minn. The funds are allocated toward a plan to secure a market plaza for immigrant products and small businesses.

"Project Come Up" of Full Faith Ministries in Minneapolis received \$15,000 to help it establish a client list and purchase lawn care and snow removal equipment. The project works in cooperation with several Black church youth outreach programs, and mental health and drug counseling initiatives to gain employment skills and income as business owners.

The SDOP committee granted \$10,000 to the "Permit and License Project" of the Kurdish Youth of America in Fargo, N.D. The funds will be used to help individuals in immigrant communities obtain motor vehicle licenses, creating a wider range of employment options.

Addressing the bitter discourse that currently characterizes both sides of the political spectrum, Nelson said, "We have not learned very well to listen. ... We are trying to find the answer on the extreme right or the extreme left."

The answers, he said, are complex, but the current political climate prevents cooperation in problem solving.

He added, "There's no community being built" because it's politically impossible for a member of one party to sit down with a member from the other party.

"What we see in Washington is a lot of posturing," he said, because members of Congress must work in front of "media that don't let go 24 hours a day."

And the answers, he said, are not as simple as the ones proposed by the far right and far left. And political leaders, he said, are "fighting to stay away from the complexity of issues."

The solutions, he said, must come from the local level. "There's power in what we have on the ground," he said, and added a caution, "If we the people don't take [the power] back, Congress will run amok."

One of the ways the Office of Public Witness plans to work toward strengthening the grass-roots political movement is through Ecumenical Advocacy Days slated in Washington March 25-28. Experts will train participants on policy issues and advocacy, culminating with lobby visits in the nation's capitol. ### Racial ethnic ministry grants awards

The Synod of Lakes and Prairies' Committee on Racial Ethnic Ministry granted more than \$17,000 in scholarships for 12 students during the 2010-11 academic year.

In addition, the committee distributed a total of \$4,000 in institutional awards for tribal colleges within the "boundaries of the synod and Cook College."

### Synod approves support 'in concept' for Pres House refinancing effort

The Synod of Lakes and Prairies approved "in concept" a recommendation from its Finance Committee to support refinancing on a residential apartment building owned and operated by the Presbyterian Student Center Foundation, commonly known the Pres House, in Madison, Wis.

To support the refinancing, the synod will pledge up to \$2.5 million of synod investments as collateral for the refinanced loan.

The synod empowered the Finance Committee to negotiate details of the financial arrangement.

Refinancing, if successful, is expected to increase cash flow for Pres House.

### Kocourek installed as moderator, Prouty is vice moderator

The Synod of Lakes and Prairies installed Elder Ardeth Kocourek, South Dakota Presbytery, as moderator of the synod for 2011 when it met Jan. 16-18 at Mount Olivet Retreat Center, Farmington, Minn. The synod also installed the Rev. Scott Prouty, Minnesota Valleys Presbytery, as vice moderator.

Kocourek, Martin, S.D., describes herself as a "transplanted Iowan, who thinks of herself as an educator."

She has been a teacher and library-media specialist in the Bennett County (S.D.) Schools, part-time instructor for Oglala Lakota College in Kyle, S.D., a farm homemaker and operator, member of the South Dakota State Library Commission, and a 4-H and extension leader.

Kocourek holds a bachelor's degree from the University of Northern Iowa, Cedar Falls, and a master's degree from New York University.

For the synod she serves on the Personnel and Synod School committees.

Prouty, a clergy commissioner from the Presbytery of Minnesota Valleys, was ordained as a minister of the word and sacrament in 1995 at First Presbyterian Church in Redwood Falls, Minn., where he has now served as pastor since 2002.

He received a bachelor's degree from Mankato (Minn.) State University in speech communications with a minor in gerontology and earned his Master of Divinity degree from the University of Dubuque (Iowa) Theological Seminary.

# Synod sets collegiate ministry as priority

Acting on a recommendation from its Ecclesiastical Relations Committee, the Synod of Lakes and Prairies voted to establish collegiate ministries, including campus-, congregational- and chaplaincy-based ministries, as a programmatic priority.

The synod also voted to partner with the General Assembly Office of Collegiate Ministries.

services, (5) improved financial position, (6) optimizing fundraising, and (7) low-income older adults.

Under the structure and leadership initiative, PHS plans to "establish a new management structure that focuses and positions us for the future and, in so doing, to excel in leadership development and growth of people," Lindh's presentation stated. He also pointed out that PHS will "continue strong internal development people systems ... based upon our core Christian beliefs and values."

The home- and community-based services initiative emphasizes growth in services provided away from its residency-based facilities. The goal is to increase the number served in home- and community-based services from the current level of 5,800 to 60,000.

The "second geographic area" initiative calls on PHS to select a "metropolitan area where PHS can have a concentrated hub-and-spoke system very similar to that in the Twin Cities area."

To continue its development of traditional facilities, PHS plans to develop new campuses on a modest scale and experiment with smaller communities that are "well connected to the services of the entire PHS system," according to the organization's website.

PHS will attempt to improve its financial position through efficiency in operations, and increasing liquidity, reducing long-term debt and growing its endowment.

To optimize fundraising, PHS plans to "grow philanthropy, to build endowment, strengthen mission benevolence and assure quality-of-life programs like spiritual care and wellness," its website states.

Noting that the final initiative of the plan identifies services for low-income, older adults, Lindh pointed out that 20 percent of those currently served "under our roofs" are very low income. The initiative calls for PHS to "provide more services for very low-income, older adults, integrating and-or coordinating those services with existing PHS communities."

In addition to speaking about PHS, Lindh also presented reports on the other service providers affiliated with Presbyterian Association of Homes and Services for the Aging, including facilities in Ackley, Dubuque and Washington, Iowa, and Lincoln, Neb.

### Synod receives funding for Military Sensitivity Training

The Synod of Lakes and Prairies, in partnership with the Synod of Living Waters, has received a \$12,000 Heiserman Grant to support a "Military Sensitivity Training Initiative."

Heiserman funding is issued through the Presbyterian Church (U.S.A.) to programs that reflect partnership between a synod and at least one other governing body.

The funding for military sensitivity training will support travel, lodging and meal compensation for up to 15 individuals to participate in the training program.

The grant is the second Heiserman Grant the synod has received. The first grant, which totaled \$50,000, supports the "Parish Resident Internship Program" at Church of All Nations in Minneapolis.

## Synod extends time for final task force report

The Synod of Lakes and Prairies received an interim report from its Administrative Review Task Force on the Future of the Synod, and extended the task force's time for a final report to no later than April 1.

The motion also stated that "the final report shall be referred to the synod's Steering Committee for recommendations to the synod no later than the January 2012 meeting."

Answers to questions 1 and 5 from the Application for Candidacy – Katherine Pater

1) As a Christian in the Reformed tradition, I believe that all children of God are called to share in God's re-shaping of the world into a reflection of the Kingdom of God. Paul writes that we are all pieces of one body, made to serve one another and the world. We all have important roles to serve in God's ministry on earth.

I have felt since I was quite young that I have been called to ordained ministry. While I do not know where exactly where God is leading me after seminary, I know that God has lead me quite far: from a childhood without church, to the realization in college that the Reformed tradition was where I felt theologically at home, to a seminary where I am finally exploring what that theology means for my vocation and my future ministry. I know that if God has led me this far, he will find a place for me to be and grow and serve in the future. I believe with my whole heart that while I am still just one small part of a body that contains billions of believers, that God is calling me to preach and educate God's people.

5) I grew up in Brookfield, WI and no matter where God leads me I will always be a Midwestern girl with strong Irish roots. I was not raised in a religious family, but even as a young child I was interested in religion in general and Christianity in particular. As I

grew older, I felt more and more strongly that I was called to be part of the Christian community and to serve it in a position of ordained ministry.

These religious inclinations were for most of my life opposed by my parents, who believe that organized religion has done quite a lot of damage to the world. They were (and are) not entirely wrong about this, but I have always believed that the Church can be a force for social change, healing, and good. Despite these disagreements, my parents have come to accept my desire to become a pastor, and I am grateful for their perspective. It is good to be reminded that while the teachings of the Church can be a source of joy, they can also be a source of pain. My family will not let me forget that.

When I was in college I went through a period where I was not sure if I wanted to pursue ordained ministry anymore. I had trouble finding a church where I felt comfortable and whose theology made sense to me. After a year of searching and giving up on finding somewhere that "fit," I stumbled into a Presbyterian campus church at my undergraduate school where I everything just clicked. Around the same time, a dear friend of mine mentioned to me that I should "go into ministry," despite the fact that I had never discussed with that I was considering such a thing. I took that as a sign that I should take this strange, still small voice seriously, and I have been pursuing a life in ordained Presbyterian ministry ever since.

I am currently in my second year of Divinity school, and I truly do feel that God has led me to this place. From the classes I take to the friends I've made and church community I've found (and am currently serving as an intern), I feel that everything I am doing is part of God's plan for my life and ministry, even when I work long, hard hours. In my spare time, I enjoy competitive Irish dancing, running, spending time with friends and family, and reading lots of fantasy and science fiction books. These things keep me healthy and sane.

6) Ministers of the Word and Sacrament are members of the Presbyterian community who are specially trained to preach and to teach God's people about God's hopes and dreams for the world and to lead them as best they can into better, more wholesome lives in Christ. They are expected to wholeheartedly and correctly perform the sacraments of baptism and communion, to assist the governing of the church community (though they do not, and should not, have full power over the church's governance) according to the laws set down in the Book of Order and the Book of Confessions. Though imperfect human beings, they are also called to help their fellow Christians through trying times and joyful ones by offering them spiritual advice based in the teachings of the church to the best of their ability.

While keeping in mind these pastoral duties, they are also called to be a prophetic voice in their communities, leading them to further the values of justice, love, and equality that Jesus and His many followers through the ages have suffered and died to uphold. They are called, as Karl Barth once wrote, to approach the pulpit with a Bible in one hand and a newspaper in the other, always seeing to balance the spiritual needs of their community and the needs of this broken world. They are called to act with justice, love tenderly, and walk humbly with God.

On my good days, I am a decent preacher, an intelligent reader of scripture, and good at teaching (and managing) children. But I know I have a much to learn when it comes to preaching, listening, and responding to people at a pastoral level. I tend to process the

world using my brain and not my heart, and I know that sometimes this tendency makes it hard for me to connect with people.

- I. Milwaukee Habitat for Humanity<sup>®</sup> gave a presentation at our December 2010 Mission Partnerships meeting. As a result of a three-year Neighborhood Stabilization Program 2 grant received from the U. S. Department of Housing and Urban Development, this Habitat chapter is committed to
  - A. build 100 homes on foreclosed properties, and
  - B. engage in a three-year campaign to raise \$ 6.5 million to match the grant funds.

Mission Partnerships is encouraging congregations to assist in this ministry by contributing funds and organizing work crews. MPT has committed to match up to \$500 contributions from congregations (up to a total of \$3,000). We recognize that some congregations are not in the Milwaukee area, and so this matching grant is available for your nearest Habitat for Humanity® chapter. #### For Information

 The Council voted at its February meeting for the Presbytery of Milwaukee to be a cosponsor for the "People of Faith United for Justice Day" at the Wisconsin State Capitol, March 15, 2011. The Presbytery of Milwaukee will contribute \$100 to be a co-sponsor.

Five ecumenical and interfaith organizations in Wisconsin are sponsoring this event. They are: Interfaith Conference of Greater Milwaukee, Lutheran Office for Public Policy in Wisconsin, Madison-Area Urban Ministry, Wisconsin Council of Churches, and WISDOM. The goal is to bring more than 500 constituents from religious communities throughout Wisconsin to speak with a united voice to our elected officials in Madison. - The Council will send two representatives and the Executive Presbyter to the Synod of Lakes and Prairies Consultation March 28-29, 2011 in Buffalo, MN. The Council moves that the Proposed "Guidelines for Congregations Considering Merger with One or More Congregations and that Seek the Financial Support of the Presbytery of Milwaukee" be approved.

### <u>History</u>

The Proposed guidelines were presented to the Presbytery at its November 2010 meeting for a first reading.

Proposed Guidelines for Congregations considering Merger with one or more congregations and that seek the financial support of the Presbytery of Milwaukee

Consequently, you are no longer foreigners and aliens, but fellow citizens with God's people and members of God's household, built on the foundation of the apostles and

prophets, with Christ Jesus himself as the chief cornerstone. In him the whole building is joined together and rises to become a holy temple in the Lord. (Ephesians 2:19-21)

We often identify our faith communities with the buildings that house them yet we affirm that ministry is more than the bricks and the mortar; Jesus alone is the cornerstone on which we build. Buildings may house our ministries but Jesus is always calling us out into the world. In other words, it's not about the building so much as it is about building up the body of Christ in whatever form is most effective.

And yet for a particular community of faith, for the individual church which lies nestled within the church universal, place is important -- the communities in which we live and the buildings in which we gather: our church home and home base.

In recent years, many congregations are prayerfully discerning God's leading into the future, a discussion that often leads to questions about our church buildings – how to shift our form in order to better serve our function, what to do with our buildings as congregations consider merging or closing, how congregations can be more fluid while still providing a place to meet and minister in the name of Jesus.

The Council of the Presbytery of Milwaukee has been considering these questions alongside congregations and we have put together these guidelines in order to foster discussion, open up options and partner in new visions for individual congregations. These guidelines should not be considered new policy; but they may point us toward new possibilities as we together seek the leading of God's Holy Spirit.

#### **BACKGROUND**

Particular congregations may seek new life and renewed ministry through merger with other congregations. Such a merger most often involves two or more congregations joining to form a new entity with a new name, a new roll of members, new mission, and, perhaps, a new location for worship, fellowship and mission. Whatever conditions originally prompt interest in a possible merger, the primary rationale for successful mergers is not simply survival but mission.

The product of a particular merger of two or more congregations varies with the specifics of the congregations involved. For example, the congregation resulting from the merger of two or more PC (USA) congregations would be a PC (USA) congregation that is organized, functions, and is governed as any other PC (USA) congregation. However, mergers including PC (USA) congregations and congregations outside the PC (USA) may take the form of either federated or union congregations whose organization and governance will be determined by the polity of the denomination of the merging congregations. In either case, mergers may only be completed and the resulting new congregation welcomed into the presbytery with the consent of the presbytery.

It is expected that when two or more congregations merge, the resulting congregation will locate its life and worship in one church building, chosen for its soundness and suitability for ministry, and that the other church building(s) will be sold. Other possibilities include selling all or some of the properties of the merging congregations and buying, renting, or building another site for the new merged congregation. Ordinarily, the assets of a congregation stay with that congregation as long as it is in ministry. When congregations merge, although they form a new entity, they are considered to be continuing in ministry and their assets become the assets of the new entity.

The formation of any new congregation always carries with it both promise and risk, but mergers also carry a high level of complexity. Such things as custom, history, social networks, institutional practice, denominational loyalty, resources and staff all need to be carefully and pastorally engaged. To be successful, the formation of a congregation by merger must be undertaken with the same intentionality and attention to detail as a new church development.

#### **PROPOSAL**

Any approved costs including all contracts incurred by the merger process will be paid for by the Presbytery of Milwaukee Foundation and all reimbursements shall be returned to the Foundation. All contracts must be approved by COM.

Congregations in the Presbytery of Milwaukee that are considering merger and request the presbytery's financial assistance, will:

- 1) Identify working groups of not more than 5 members from each congregation that will meet regularly to study the feasibility and desirability of merger;
- 2) Contract with a consultant/coach (from a list of COM approved consultant/coaches) who will work with the congregations for at least six months, to facilitate the merger process.
- 3.) Bring together a building assessment team of appropriate experts (architects, property managers, engineers, etc., approved by the COM) to assess the soundness and suitability for ministry of all the existing church buildings and to make a report to the congregation and COM.
  - So that the cost of qualified consultants, architects and engineers not be an impediment to
    the exploration of a possible merger, the Presbytery of Milwaukee agrees to pay the
    approved costs incurred in the employment of the consultant/coach, the building
    assessment team, and the COM advisor for their work in advance of the merger. When
    particular skills are required COM may contract with advisors who have competency in the
    identified areas of need.
- 4.) Develop a strategic plan, with the help of the consultant/coach, which includes a five year operational plan, staffing plan, and financial plan;
- 5.) Present the completed plans to the congregation and COM for approval before any decision is taken regarding merger;
- 6.) If, after consideration of the reports and the strategic plan the congregations vote not to merge, the process will end.
- 7.) If COM determines the plan is not feasible or sustainable, COM may require the participating congregations to revise and resubmit the plan.
- 8.) If the congregations vote to merge, they agree to employ the same or another, COM approved, consultant/coach for a period of at least one year to assist in "working the plan" that was developed in the six months prior to the congregations' votes.
  - It is expected that the Presbytery will be reimbursed for any such expenditures, either at the time of the merger, from the financial resources of the new congregation, or at a later date, from the sale of the properties of the merging congregations.
  - If the participating congregations decide not to merge, the costs of the consultant/coach, building assessment team, and the presbytery's advisor will be covered by the presbytery.

NOTE: COM Advisors are to be recruited, trained, and paid by the COM to be a guide between the merger team and consultant, and COM.

### Hartland, Kettle Moraine United Presbyterian Church Administrative Commission Final Report February 22, 2011

**Motion:** The Hartland, Kettle Moraine Administrative Commission moves that the Administrative Commission for Hartland, Kettle Moraine United Presbyterian Church be dissolved on February 22, 2011.

On September 27, 2005 the Presbytery of Milwaukee voted to establish an administrative commission for Kettle Moraine United Presbyterian Church to work with the session of Hartland, Kettle Moraine Church with the following authorities and responsibilities:

- 1. To inquire and identify into the causes and effects of reported dissention and division in the congregation.
- 2. To act as an agent of reconciliation within the congregation, where possible, to resolve any and all issues identified by the inquiry.
- 3. To evaluate the ability of the Session to manage effectively the affairs of the congregation and to provide for training where needed.
- 4. To determine and implement such actions that, in the judgment of the Commission, serve to further the peace, unity and purity of the congregation.
- To assume original jurisdiction in matters concerning the discipline of elders and/or members whose actions, statements and/or behaviors are contrary to Scripture, the Book of Confessions, the Book of Order and/or the denomination's standards of ethical conduct.

During the last quarter of 2005 and the first quarter of 2006, the commission established meetings with the session and pastor, and listening sessions with members of the congregation, to inquire and identify the causes and effects of reported dissention and division in the congregation (Item 1). Results of our findings were shared with the pastor who tendered his resignation on March 6, 2006 (Item 2). Temporary arrangements were made by the session in consultation with the administrative commission for short-term moderator and pastoral care.

Based upon the administrative commission's inquiry, we assumed original jurisdiction in matters concerning the discipline of elders and/or members whose actions, statements and/or behavior were determined to be contrary to Scripture, the Book of Confessions, the Book of Order and/or the denomination's standards of ethical conduct (Item 5). In the fall of 2006 the administrative commission met with specific members for the purpose of identifying inappropriate behavior and/or actions, and providing examples of more appropriate and acceptable responses for the future. Having concluded that a period of healing and renewal would be required before pursuing another called pastor, on November 1, 2006 the session and Presbytery, in consultation with the administrative commission, established an interim ministry with the Rev. Wayne Adcock.

The interim ministry continued until November 1, 2009. During that time the administrative commission journeyed with the session and congregation, monitoring the healing process, making recommendations to the session to consider for improving their ministry, and evaluating the ability of the Session to manage effectively the affairs of the congregation, providing for training where needed (Item 3). At the commission's recommendation the congregation hosted a Presbytery-wide program on "Healthy Congregations" presented by the Lombard Mennonite Peace Center on November 3, 2007. Shortly after that the session conducted a mission study with the congregation, and in May of 2008 a PNC was formed.

The work of the PNC came to fruition with the call of the Rev. Kurt Walker who began his ministry on December 1, 2009. It was the commission's decision to continue to journey with the session and congregation through the first year of Rev. Walker's ministry. During our initial inquiries made in 2005, and as part of our subsequent inquiries in the years following, it became clear that reestablishing the "peace, unity, and purity of the congregation" (Item 4) required more than resolving pastoral difficulties and healing relationships within the congregation. A significant distrust of the Presbytery of Milwaukee had developed among members of the congregation as a result of perceived actions taken, or not taken, from as early as November of 2003. In addition to healing relationships within the congregation, we also deemed it critical to take the time to heal the relationship between the congregation and the presbytery. Over the past five years we have met with the session, listened to members of the congregation, responded to concerns, and offered prayerful support in the effort to reestablish a positive relationship between the Presbytery and the congregation.

Having witnessed great strides in the congregation's healing process over the past five years, having observed the session of the congregation embrace increasing levels of effective management, and having developed great confidence in the leadership of the Rev. Kurt Walker and his relationship with the congregation, we conclude that our work is now complete. We have reestablished, to the best of our ability, the peace, unity, and purity of the congregation (Item 4). We believe the time has come to request that the administrative commission of Kettle Moraine United Presbyterian Church be dissolved and that the session and congregation be encouraged to continue their ministry and mission as faithful followers of Jesus Christ with the prayers, best wishes, and continued support of the Presbytery of Milwaukee.
