**NOTICE INVITING e-TENDER (3 BOT – 3 Envelope Open Tender)**

---

Item rate tenders are invited through the e-tendering portal (Bid No. 1000009360) by Assistant General Manager Engg (C)-III, Block 'A', 3<sup>rd</sup> Floor, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003 Tel. No.: 011-24632950 (Extn.: 2518) (Bid Manager) on behalf of Chairman, A.A.I from the eligible contractors for the composite work of “Resurfacing of Runway 05/23 & Taxiways at S.V.I.P Airport Ahmedabad” at an estimated cost of Rs. 3814.70Lacs with period of completion 18 (Eighteen) months. (Including 2 months considered for the rain of yearly monsoon season).

1. The tendering process is online at e-portal URL address <https://etender.aai.aero/irj/portal> or [www.aai.aero](http://www.aai.aero). Aspiring bidders may go through the tender document by “Guest User” login.

Prospective Tenderers are advised to get themselves acquainted for e-tendering participation requirements at “Guidelines for bidders”, register themselves at AAI e-tendering portal, obtain ‘User ID’ & ‘Password’ and go through the ‘Self Help Files’ available in the Home Page after log in to the portal <https://etender.aai.aero/irj/portal> or [www.aai.aero](http://www.aai.aero). They should also obtain Digital Signature Certificate (DSC) in parallel which is essentially required for submission of their application. The process normally takes 03 days time. The tenderer may also take guidance from AAI Help Desk Support.

Tender fee of Rs.5625/- will be required to be paid by way of online payment through HDFC gateway provided at the portal itself. **Last date and time of sale of tender document is 09/06/2015 upto 17:30 hrs.**

2. **Following 3 envelopes shall be submitted through online at e-portal by the bidder. Last date and time of submission of bids (Envelope I, II & III) is 18/06/2015 upto 17:30 Hrs.**

**Envelope –I:- Containing qualifying requirements of Contractor / Firm:-**

The tenderer shall submit their application by downloading the “PQ Proforma” from the e- tendering portal, fill-up the required information and upload the digitally signed file of scanned documents and firm’s bio-data in support of their meeting each criteria mentioned below in the “PQQ folder” in Technical Bid / Attachments Section in the portal. Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

**A) Qualifying requirements of contractors / firms.**

- i) Should have valid Registration on the Date of issue of Tender in appropriate class of CPWD/MES/P&T/Railways/State PWD/PSU/Municipal Corporations & Development Authorities of Delhi, Mumbai, Chennai and Kolkata and having Permanent Account Number (PAN).
- ii) Should have satisfactorily completed (Phase/ Part completion of the scope of work in a contract shall not be considered, **however pre determined phasing of the work will be accepted**) three works, each of Rs. 1525.88Lacs Or two works, each of Rs. 1907.35Lacs or one works of Rs. 3051.76Lacs in single contract of similar nature work like Construction of flexible pavements of airfield pavements or National highways /Expressways and experience of State highways (subject to meeting MoRTH specifications prescribed for

National Highways) during last **seven years** ending on 30.04.2015 in India. (experience in city roads/town roads etc. will not be considered).

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. **Firms showing work experience certificate from non-government / non-PSU organizations should submit copy of tax deduction at sources certificate in support of their claim for having experience of stipulated value of work.**

- iii) Should have annualized average financial turnover of **Rs. 1144.41Lacs** against works executed during last three years ending 31<sup>st</sup> March of the previous financial year. As a proof, copy of Abridged Balance Sheet along with Profit and Loss Account Statement of the firm should be submitted along with the application. **Firms showing continuous losses during the last three years in the balance sheet shall be summarily rejected.**
- iv) Should possess computerized hot mix plant to achieve output of minimum 75 MT /hr and Electronic Paver finisher of adjustable width upto 7.5 m. Documentary proof of owning and possessing required machinery and T & P shall also be submitted along with the application. Ownership can be either freehold or lease hold.

**Envelope:- II:-** Technical Bid containing scanned copy of Unconditional Acceptance of AAI's Tender Conditions and EMD (In case of EMD being submitted in form of Bank Guarantee).

EMD to be submitted either through direct bank transfer using RTGS/NEFT or using bank guarantee through e-Tendering portal of value **Rs. 76.30 lacs**. Scanned copy of earnest money deposit (EMD) of value **Rs. 76.30 lacs** in the form of Bank Guarantee as stipulated in the notice inviting tender may be submitted in "Tech Bid Folder" in Technical Bid/Attachments section of e-tendering portal along with scanned copy of Unconditional Acceptance of AAI's Tender Conditions (Performa given in Annexure-1 of Tender Document) and Integrity pact (Annexure-6). Performa of BG is given in Annexure-4 of tender document.

**Envelope-III:-** The Financial e- Bid shall be submitted in "Items" section of e-tendering portal. Unconditional rebate i.e. header discount (%) if any is to be put in "Bid Invitation Information → Price Component" section only.

- 3. Original EMD (In case of EMD being submitted in form of Bank Guarantee), and original signed Unconditional Acceptance of AAI's Tender Conditions to be sent to the **Assistant General Manager Engg (C)-III** Block 'A' 3rd Floor, Rajiv Gandhi Bhawan, Safdarjung Airport New Delhi-110003 and should reach with in two working days of opening of pre-qualification of tender. Tender of the tenderer whose EMD (In case of EMD being submitted in form of Bank Guarantee), and unconditional acceptance of AAI's tender conditions are not received by the time of the opening of pre-qualification of tender then their tenders will be summarily rejected. Any postal delay will not be entertained.
- 4. Bids Opening Process is as below:-

**Envelope-I:** containing Documents for pre-qualification bid (uploaded by the contractors / firms) shall be opened on **22.06.2015 at 1130 hours**. The intimation regarding acceptance/ rejection of their bids will be intimated to the contractors / firms through e-tendering portal.

**Envelopes-II: Technical bid opening date is 03.07.2015 at 1100 Hrs. (Depending on pre-qualification, any changes in the date shall be intimated through "Notification to Bidder" section).**

If any clarification is needed from the bidder about the deficiency in his uploaded documents in Envelope – I and Envelope – II, he will be asked to provide it through collaboration folder in e-tendering portal. The bidder shall upload the requisite clarification/documents within time specified by AAI, failing which tender will be liable for rejection.

**Envelopes-III:** The financial bids of the contractors/firms found to be meeting the qualifying requirements and technical criteria shall be opened on **08.07.2015 at 1100 hrs.**

**(Depending on prequalification bid evaluation and Technical Bid evaluation any changes in the dates shall be intimated through “Notification to Bidder” section).**

5. AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI also reserves the right to call off tender process at any stage without assigning any reason.
6. AAI reserve the right to disallow issue of tender document to working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain/Temporary/Permanent debar by any department of AAI. **AAI reserve the right to verify the credential submitted by the agency at any stage (before or after the award the work). If at any stage, any information /documents submitted by the applicant is found to be incorrect/false or have some discrepancy which disqualifies the firm then AAI shall take the following action:**
  - a) **Forfeit the entire amount of EMD submitted by the firm.**
  - b) **The agency shall be liable for debarment from tendering in AAI, apart from any other appropriate contractual/legal action.**
7. Consortium / JV companies shall not be permitted; No single firm shall be permitted to submit two separate applications.
8. Purchase preference to Central Public Sector Undertaking shall be applicable as per the directive of Govt. of India prevalent on the date of acceptance.
9. **If the entity participating in any of the tenders is a private or public limited company, Partnership firm or proprietary firm and any of the Directors/Partners/Proprietor of such company is also a director of any other company or partner of a concern or a sole proprietor having established business with AAI and has outstanding dues payable to the Authority, then the said entity shall not be allowed to participate in AAI tenders.**
