

**ZIP LINE RIDE RELEASE OF LIABILITY, WAIVER OF CLAIMS,
EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

Please read and be certain you understand the implications of signing.
Express Assumption of Risk Associated with use of Zip Line Ride and Related Activities

I (name) _____ do hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with zip line riding activities to which I am about to engage, including but not limited to:

- 1) The rotation and spinning movement of the Zip Line Ride that will cause me spin or move in an uncontrollable manner;
- 2) The changing condition of the equipment used during Zip Line riding and the speed and movement of riding;
- 3) The speed and force of the zip line retracting me up or down during use, and the inherent risk of possible injuries caused by that force;
- 4) The possibility of getting skin burns or rash from the harness during use;
- 5) Inclement weather, lighting, variances and extremes of wind, weather and temperature;
- 6) My sense of balance, physical condition, ability to ride and hold on or follow directions;
- 7) The presence of insects and flying life forms;
- 8) Equipment failure or operator error;
- 9) Heat or sun related injuries or illnesses, including sunburn, sunstroke or dehydration;
- 10) Fatigue, chill and / or reaction time and increased risk of an accident

I understand that the above-described risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. Furthermore, Magic Jump Rentals Inc. employees seek safety but they are not infallible. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions and the equipment being used might malfunction.

I specifically acknowledge that I am at least forty five pounds and 8 years old, do not have any health ailments including, but not limited to, back, neck, heart, motion sickness, seizures, pregnancy, dizziness, or other ailments which may be aggravated by this activity, and that I have read, understand and agree to abide by all Zip Line riding instructions at all times, and that I have been trained in the safe use of Zip Line equipment to my complete satisfaction, and I am physically/mentally able to participate in the Zip Line riding activities to which I am about to engage. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition that I might aggravate or cause myself.

I specifically waive any defense insofar as this contract is concerned that may arise as a result of any law and / or regulation or policy that may impact its enforceability. In consideration of being allowed to participate in the above-described activities, as well as the use of any of the facilities and the use of the equipment of the below listed releases, I hereby agree as follows:

- 1) **To waive and release any and all claims based upon negligence, active or passive, that I may have in the future against all of the following named persons or entities herein referred to as releasees: Magic Jump Rentals Inc.**
- 2) To release the releasees, their officers, directors, employees, representatives, agents, and volunteers from liability and responsibility whatsoever and for any claims or causes of action that I, my estate, heirs, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether caused by active or passive negligence of the releasees or otherwise. By executing this document, I agree to hold the releasees harmless and indemnify them in conjunction with any injury, property damage or loss of life that may occur as a result of engaging in the above activities.
- 3) By entering into this Agreement, I am not relying on any oral or written representation or statements made by the releasees, other than what is set forth in this Agreement.

I hereby declare that I am of legal age and am competent to sign this Agreement or, if not, that my parent or legal guardian shall sign on my behalf and that my parent or legal guardian is in complete understanding and concurrence with this Agreement.

I have read this Agreement, understand it, and I agree to be bound by it.
