#### **RULES & REGULATIONS (REQUIRED)**

- (1) Courtesy and proper language is required when dealing with other contestants, chaperones, pageant staff, production staff and hotel/venue staff.
- (2) Contestants must be on time to all scheduled events. This includes but is not limited to rehearsals, reporting to the dressing rooms at the required times, meetings, meals, etc.
- (3) Contestant and parents understand that if an updated contestant photo or bio is submitted after an original photo or bio has been submitted, Future Productions will make every effort to replace the original photo or bio, but, Future Productions cannot guarantee all items will be replaced.
- (4) Contestants may not leave the state preliminary pageant with family or friends until the completion of the pageant.
- (5) To leave the group (for example: restroom breaks) contestants must advise a staff member where they are going.
- (6) Contestants and their family will be responsible for any medical expenses incurred during the pageant.
- (7) There is no refund of deposit if contestant is unable to attend the pageant.
- (8) Bounced checks will be charged an additional \$30.00 per bounced check. Sponsorship bounced check fees are the responsibility of the contestant.
- 9) No family, friends, coaches, personal helpers, etc. will be allowed backstage or on-stage at any time for any reason.
- (10) Outside of the competition, contestants, parents, friends, relatives, etc. should not approach the judges, the judges' coordinator, or auditors at any time for any reason.
- (11) No food or drinks in the dressing room.
- (12) No cell phones are allowed in the dressing rooms, interview rooms, rehearsals or backstage during the pageant events.
- (13) No cameras, camera phones or video cameras are allowed in the dressing rooms or backstage at any time.
- (14) No smoking, illegal substances or drinking of alcoholic beverages during the pageant weekend.
- (15) After the crowning...only the Official Photographer will be allowed on-stage with a camera. Following completion of the official photographs, the stage will be opened to general public and their cameras.
- (16) Contestants may not leave the hotel or venue at any time during the pageant weekend. This includes going to the parking lot.
- (17) Contestants may not leave their assigned hotel room following contestant bed check.
- (18) Visitors are not allowed in contestants' hotel rooms, including, but not limited to, parents, friends, family, hairdressers, etc.
- (19) The contestant(s) shall be responsible for all incidental charges at the hotel.
- (20) Room Service will be cash only. All room service bills and phone calls made from the hotel rooms are the responsibility of the contestant.
- (21) Failure to adhere to these rules can result in the disqualification of the contest and in her removal from the pageant.

# SPONSORSHIP INFORMATION

#### **SPONSORSHIP**

This sheet refers to your registration fee to enter the state pageant. Registration fees are used to cover the costs of materials, postage, stage set and auditorium, contestant hotel rooms, meeting rooms, judges, awards and prizes. There will be no additional fees required for participation.

#### REQUIRED DEPOSIT

A minimum deposit of \$199.00 is required to secure your position in this year's state pageant. This deposit will be deducted from the total registration fee as listed in the cover letter that accompanied this packet. You can either secure the sponsors to pay for your registration fee deposit or pay the deposit yourself via check or credit card. To send in your required deposit, please fill in the appropriate information in Section A of the Registration Form, cut along the dotted line, and mail to us your deposit along with Section A by the due date stamped on the Registration Checklist. If you find that you need more time to acquire your deposit payment, please contact us and we will set up an extension for you. As soon as you send in your deposit, we will automatically make the necessary plans for your participation in the pageant. Therefore, if you should withdraw from the pageant for any reason, there will be no refund for the deposit. Any money sent in above the deposit amount cannot be refunded, but can be transferred to the following year's pageant.

#### **ACQUIRING SPONSORS**

If you or your family are not wanting to personally pay the registration fee, you are encouraged secure sponsors to pay your registration fee. Some ladies prefer to pay the fee themselves like you would to take dance lessons, go to camp, join a traveling sports team, etc. Either way you do it is fine by us. Sponsorship from businesses can be tax deductible as an advertising expense. Names of sponsors are listed on the state pageant program book and website under the name of the contestant being sponsored. The following information should prove helpful in securing a sponsor or sponsors.

#### **USING** www.gofundme.com

Over the past couple years, we have been working to find a great online resource to help some of our contestants in raising sponsorship for the state pageant. Now, we believe we have found a website that will make it easy for each of you to reach out to your friends and family to ask them for their support as you start your journey to becoming Miss USA or Miss Teen USA. The online resource is **www.gofundme.com**. This website is designed to work together with a PayPal account to allow you to raise funds using social media tools like Facebook,



Twitter, Email and more. You can share your GoFundMe page with all of your friends and family and reach out to them for their support in your quest for the title. Please keep in mind that Future Productions does not own GoFundMe.com, nor are we associated

with GoFundMe.com. Any questions about their service should be directed to GoFundMe using the information provided on their website.

#### WHO TO ASK

- (1) Personal Contributions: Do consider many small donations from neighbors, friends, and relatives. This is a very successful method. We suggest you make a list of people who you know well and who you feel will be excited to see you have this opportunity. Then ask each person for a donation of \$35-\$50. This is basically what someone might spend on a gift or to send you flowers. This gives people who love you a chance to be a part of your big event. Contestants receive significant contributions from collections made at Mom or Dad's work or clubs.
- (2) Business Firms: Banks or larger businesses are often very willing to be sponsors, as are accountants, dentists, doctors and insurance agents. Consider places where your family has recently made a major purchase; real estate agents, car dealers, and furniture stores are possibilities. A place where your parents work should be considered. Smaller businesses are very good, particularly if your family does regular business there. Examples are grocery stores, service stations, cleaners, clothing stores, hardware stores, etc. Don't overlook places not frequently visited, such as funeral homes. Also, inform the business that the sponsorship is a tax deduction as a form of advertising.
- (3) **Community Organizations:** This includes groups such as Jaycees (Jr. Chamber of Commerce), Rotary Club, Optimist Club, Kiwanis Club, Chamber of Commerce, American Legion or VFW.

# WARDROBE INFORMATION

#### HAIR & MAKE-UP

At the national pageants, you are expected to be able to do your own hair and make-up. At the state level, we do allow you to provide your own assistants, should you need it. Make-up artists & hair stylists are allowed to meet their contestant in a designated meeting space on both Saturday and Sunday approximately 75 minutes before showtime. In order to do this, the make-up artists & hair stylists must have a ticket for that day's show. At no time will make-up artists or hair stylists be allowed backstage, in the contestant dressing rooms or in the contestant sleeping rooms.

**Stage Make-up**: While you always want your natural beauty to shine, please note that for stage and television, you will want to wear more make-up than you would on an everyday basis. Stage lights have the tenancy to "wash people out". This being said, you will want to make sure that your eye make-up is darker than usual. We also recommend wearing false eyelashes to really make your eyes pop. An oily/greased body is not permitted during the swimsuit competition.

Interview Make-up: You are not under bright lights, but you are at a close distance to the judges so you'll want to look your best. Please do not "cake on" your make-up as you want them to see your natural beauty.

#### INTRODUCTION OUTFIT

The Program Finals open with the Introduction Number. Each contestant should be dressed in a black and/or silver outfit. Introduction outfits can be a simple black dress, and pant/top combination, a skirt and top, etc. Accents, jewelry and shoes should also be black or silver and compliment the outfit. Remember, this should be a fun and fashionable look!

#### **INTERVIEW**

Your interview attire should be similar to what you would wear for a modeling call or interview. Attire could be a cute dress, pant suit, pants & blouse, skirt & jacket, or a skirt & blouse. Jewelry should be appropriate for your outfit and should not be distracting. You will meet with each judge for a short interview, during which each judge will try to get an idea of who you are as an individual. They will seek a young woman capable of expressing herself clearly, intelligently, and confidently. This is your opportunity to impress the judges with your opinions, ability to communicate, and overall sense of self. They are not looking for rehearsed answers.

#### **EVENING GOWN**

Judges focus on poise, overall appearance, sense of fashion and style. No single detail of the gown, hair or make-up should garner attention. The overall effect should be a reflection of your personality. It can be any color or style. A variety of styles will be seen during the event, from formal gown to a simple, elegant dress. This could be your prom gown, homecoming dress, or a gown that you borrow from a friend. The most important factor to consider is if the gown is age appropriate for the candidate. All evening gowns must be floor length. No props (gloves, parasols, fans, bouquets, hats, etc.) will be allowed.

#### **SWIMWEAR**

Judges will focus on overall fitness and the poise with which you carry yourself. Physical measurements are NOT part of the judging! TEEN contestants are required to wear a one-piece swimwear of any solid color (we highly recommend that contestants DO NOT wear monokinis - small cut-outs are ok, but should be appropriate for a Teen for wearing onstage). MISS contestants can wear either one-piece or two-piece swimsuits and must be solid in color. No thongs or Brazilian cuts will be allowed. All swimsuits must be a solid color (no patterns, etc.). Swimsuits can have piping or trimming of a different color, but the main part of the swimwear must be solid in color (see the samples on the back of this page). Please do not wear any jewelry or panty hose, or use any baby oil. No wraps, surongs or coverups are allowed during the swimwear competition. You should reflect a healthy, fit and confident physical appearance. Contestants can wear a coverup/robe to stay warm while in the dressing room, but the coverup/robe must be left in the dressing room, as it cannot be worn backstage or onstage at any time.

#### **SHOES**

Heels should be worn for evening gown and swimwear, and should compliment your outfit. Shoes with lights on them are not allowed for competition. Shoes for your interview outfit should simply compliment your outfit. Introduction number shoes can be heels, boots, or tennis shoes - whatever fits the look!

#### REHEARSALS, FREE TIME, ETC.

During pageant rehearsals, we require that all contestants wear casual, comfortable clothes. Please wear jeans, yoga pants, or sweat-pants and a t-shirt or casual top. In addition, please wear comfortable, flat shoes for rehearsal, but please bring your competition heels to rehearsals so that you can practice walking in them.

#### **PIERCINGS AND TATTOOS**

Body piercings and tattoos are allowed. Often times, contestants decide to remove body piercings (belly button, nose, eyebrow) during competition. Additionally, contestants sometimes prefer to cover their tattoo(s) during competition. For this, we recommend a product called dermablend (www.dermablend.com).

# FREQUENTLY ASKED QUESTIONS

#### Q: Why is there a registration fee?

A: Like taking dance lessons, joining a softball team, going to camp, or any other activity that you sign up to participate in, producing an event of this caliber does call for some financial expenses. The registration fee each contestant is required to pay covers event production expenses including, but not limited to: contestant meals, busses, hotel rooms, venue rental, postage, judge's flights and accommodations, trip for the winners to the national pageants, sound and lighting technicians and rentals, etc. We feel that we have done a great job on page 17 of offering suggestions on the best way to go about finding sponsors if you and your parents do not want to pay the fee out of pocket.

#### Q: When will the national pageant be televised?

A: The MISS USA® national pageant is typically televised in the later Spring or early Summer each year. The MISS TEEN USA® national pageant, is typically produced in July or August, but is not always televised.

#### Q: What if I raise more sponsorship money than the required registration fee?

A: You may collect more than the required registration fee. If you do collect over the required amount of the registration fee, please send in the full amount to the state pageant offices, and we will reimburse back to you the difference during the check-in on the first day of the pageant (so long as the sponsorship is received at least 3 weeks prior to the state pageant to allow time for checks to clear). You may then use the additional money for any additional expenses you may incur during the course of your preparation and competition in the pageant. The pageant will only refund amounts over \$10.

#### Q: Do I need a different gown for finals than the one I wear for preliminaries?

A: No. We highly recommend wearing the same gown for both preliminaries and finals. Nearly all contestants at the state pageant wear the same gown for both.

#### Q: What is the "Introduction Outfit" for?

A: At the beginning of the show for the pageant, each contestant will be introduced to the audience during an upbeat introduction (contestant will not sing or dance).

#### Q: Do I need a talent to compete in the state pageant?

A: There is no talent portion to the Miss USA and Miss Teen USA pageant system. There are three equally scored categories, including interview, evening gown, and swimwear.

#### Q: Are there any height or weight requirements to compete in the pageant?

A: Absolutely not! Each contestant in our pageant is an individual and the judges are looking for body proportion and personality, not a specific body measurement.

#### Q: What if I have more than 10 sponsors?

A: You may have as many sponsors as you wish. We do want to stress, however, that only 10 listings (limited to 75 characters per line including spaces) of sponsors can be listed in the state pageant program book and on the website next to your name. In the event that you have more than 10 sponsors, you can simply combine sponsors on a line, so long as each line does not exceed 75 characters including spaces (Example: Hy-Vee Food / Smith Shoe Repair). Or you may list them as something like: "Sponsored by the Community of \_\_\_\_\_\_\_."

#### Q: What happens if I can't get my registration materials in before the deadlines?

A: Deadlines are very important to us in order to make timely program preparations. However, we realize that unexpected circumstances can arise and that the collection of sponsorship may take longer than expected. Therefore, extensions on due dates are available when needed. If you need an extension, please call or email the state pageant offices and request a new due date.

#### Q: When will the semi-finalists be named?

A: The semi-finalists in the pageant will be named during the first portion of the pageant finals on the last day of the pageant weekend. No one will know who the semi-finalists are until that moment in the pageant finals show. All contestants will participate throughout the pageant finals show.

#### Q: If I am not named as a semi-finalist, will I still be in the pageant finals?

A: Absolutely. The pageant finals will start with every contestant being introduced and all contestants will participate in the gown review, special awards, naming of the semi-finalists, musical performances, and naming of the titleholders. You will be on stage at many times during the pageant finals, even if you are not named as a semi-finalist.

#### Q: Do I need to pay for my meals during pageant weekend?

A: No. Most all of your meals throughout the state pageant weekend are provided by the state pageant. Although all of your meals are provided, we do recommend that you are prepared for any additional meals that you may want.

#### Q: Do I need to pay for my hotel room during pageant weekend?

A: No. Your hotel room during the pageant is provided for you by the state pageant. You will be roomed with one other contestant in a room with two beds. If you choose to arrive the night before or stay the night after the pageant, your room for those nights would be at your own expense.

#### Q: How many other contestants will I room with at the hotel?

A: Each contestant is paired with one other contestant in order to share each hotel room. Each room will have two beds, so each contestant will have their own bed. In order to be respectful to the contestant with whom you are sharing the room, only the two of you are allowed in your hotel room (no family or friends allowed at any time).

#### Q: Will the photo that I sent in with my application or the photo I send in with my registration materials be returned to me?

A: Unfortunately, the state pageant offices must keep your application and contestant photos on record for the Miss Universe Organization, and these photos will not be able to be returned to you after the pageant. Please be sure that you are not sending us your only copy of the photo.

#### Q: Who are the state pageant judges?

A: The state pageant judging panel consists of experienced judges from the modeling industry, entertainment industry, pageant industry, media, and the business community.

#### Q: Is the state pageant televised?

A: The state pageant is not televised, but videos of the state pageant will be available for sale during the state pageant weekend.

#### Q: Can I make copies of the white sponsorship form?

A: Please make as many copies of the white Sponsor Form as needed for the appropriate number of sponsors that you secure. If you are getting individual cash donations from family and friends who do not need or want a receipt, you do not need a white Sponsor Form for each individual. Do, however, send one white Sponsor Form showing the combined amount donated by family and friends.

#### Q: If my family or friends want to attend the pageant, where do they stay?

A: In this packet, as well as on our website, you will find the hotels which the state pageant recommends for family and friends. Be sure to tell them to mention to hotel reservations that they are "Friends or Family of a Miss USA/Teen USA state contestant" so they get a discounted rate!

#### Q: Can my family or friends take photos or videotape the pageant?

A: Unfortunately, video cameras and still cameras are not permitted at the pageant preliminaries and pageant finals. Photos and DVDs will be available for purchase.

#### Q: How can I order professional photos or videos of the pageant?

A: A couple weeks prior to the state pageant weekend, you will receive an order form for both photos and videos. If you would like to purchase either of these items, you can simply fill out the form and turn it in to the official pageant photographer and videographer at the state pageant check-in on the first day of pageant weekend. In addition, you can turn in that order form anytime throughout the state pageant weekend. Please note that no video and no photography will be allowed during the show by event attendees.

#### Q: How do my family and friends get tickets to attend the pageant?

A: They can purchase them online with a credit card at www.futureproductions.net, or they can purchase tickets with cash at the pageant (please keep in mind that the show can be sold out, so it is best to have them purchase the tickets in advance online). Please note that online tickets sales are not mailed, but must be picked up by the purchaser at the will call ticket table at the pageant.

#### Q: Where can I order items that I may need for the pageant, as well as t-shirts, videos, memorabilia, etc.?

A: For your convenience, we have many items available for sale on our online store at www.futureproductions.net/store. In addition, our staff will have many items available for you to purchase onsite during the state pageant weekend.

#### Q: What type of photo should I use for my official state pageant photo in the program book?

A: Your program book photo should be a head and shoulders potrait photo. We recommend a photo with no hands or hats in the photo. This will be used in the state pageant program book and will in no way be judged.

#### Q: What should I do if a sponsor gives me cash for my registration fee?

A: If you receive cash contributions for your registration fee, you may put that money into a money order or send a personal check. Please DO NOT send cash through the mail at any time. If your cash collected exceeds the registration fee for the state pageant, then you do not have to send in the additional cash.

#### Q: How many contestants compete at the state pageant?

A: The number of contestant vary from year to year, but each year approximately 20-50 contestants compete for the Miss title, and 40-70 contestant compete for the Teen title.

#### Q: What should my family and friends wear to the pageant?

A: We recommend anything from business casual to formalwear for the pageant preliminaries and pageant finals.

#### Q: Can I wear a sarong or wrap with my swimwear?

A: Because the new titleholder is unable to wear a cover-up or wrap at the national pageant, we cannot allow any type of sarong or wrap during the swimwear portion of the state pageant.

#### Q: When will this year's contestants' photos be posted on the website?

**A:** This year's contestants' photos will be posted on the state pageant website approximately one day prior to the state pageant.

#### Q: Do I need to find sponsors?

A: No. If you would prefer to pay the sponsorship fee or if your parents would like to just pay the sponsorship fee, there is no need to seek assistance from businesses and individuals in your community.

#### Q: Will my sponsors be listed on the website?

A: Yes. Each contestants' ten sponsor listings will be listed on the website with her photo. Each sponsor listing is limited to 75 characters including spaces.

#### Q: If my family or I pay the registration fee and I do not have sponsors, what will get listed on the website?

A: We would encourage you to submit something like the following to appear on the website and in the program book, "Thank you to my family and friends for your support!"

#### Q: Can I purchase an ad for the state pageant program book?

A: Yes. Once we have received your complete registration materials, you will receive from us another packet containing information on how to secure a spotlight page for yourself.

#### Q: Why am I asked to provide a report card / transcript?

A: This documentation is merely used as a proof of residency. The judges never see this. You will NOT be penalized for poor grades or rewarded for exceptional grades at the state pageant.

#### Q: If I need to check FALSE on the morals clause in the contract, will I automatically be disqualified?

A: No. Each individual case is given consideration. We do ask, however, that you quickly provide the documentation requested by the state pageant offices in order to get the approval process started.
