

## Need an incentive to get back in the gym? MetroPlus has what you're looking for.

**As a MetroPlus Gold member, we want to help you stay healthy.** To help you do this, MetroPlus will reimburse you up to \$250 every six months for the cost of your exercise facility membership. If your spouse is a MetroPlus Gold member, they are also eligible for the same reimbursement every six months.

**What types of health clubs qualify?** Exercise facilities that maintain equipment and programs that promote cardiovascular wellness qualify for reimbursement. Memberships in tennis clubs, country clubs, weight loss clinics, spas or any other similar facilities will not be reimbursed. Lifetime memberships are not eligible for reimbursement. Reimbursement is limited to actual work-out visits. We will not provide reimbursement for equipment, clothing, vitamins or other services that may be offered by the facility (massages, yoga, etc.)

**How do I become eligible?** In order to be eligible, you must be an active member of the exercise facility. Your membership with MetroPlus must be current and paid to date at time of submission.

If you are eligible to receive Health and Fitness Reimbursement through the New York City Management Benefits Fund, you are not eligible to receive reimbursement through MetroPlus.

**How do I obtain the reimbursement?** In order to obtain reimbursement at the end of the six-month period (you must wait until six months have passed):

• Submit a copy of your current facility bill which shows the fee paid for your membership.
