GUIDE FOR CALCULATING CREDITABLE YEARS OF EXPERIENCE FOR CANDIDATES FOR APPOINTMENT AS INSTRUCTORS

Note: Read this document and complete items numbered 1-7 below

The Collective Agreement between the Board of Governors and the Dalhousie Faculty Association provides a salary scale for Instructors and Senior Instructors who are Members of the bargaining unit. Candidates hired to Instructor positions are placed on the scale according to their creditable years of experience, and the Board consults with the Association-s nominees to the joint Association-Board Committee prior to making an appointment. The purpose of this form is to assist you in providing information for use in considering your placement on the salary scale. You may wish to consult with the Dalhousie Faculty Association for further assistance.

Give specific details concerning your educational background in the appropriate space below. Graduate degrees are considered as creditable experience within the limits and requirements specified by the Collective Agreement.

Information about your other previous experience should be provided below in the Experience section. Be sure to note any employment experience which was less than full-time, and <u>specify</u> the fraction of full-time duties performed. At the minimum, your placement on the salary scale must recognize the following experience:

- (A) appropriate graduate degrees, if any:
- (B) years of experience as an Instructor or similar position at Dalhousie University or similar institution; and,
- (C) years of employment experience elsewhere that is related and relevant to the functions of the Instructor-s specific position at Dalhousie University. (The maximum to be allowed under this category C shall be five years.)

Your total claim will be the sum of the various parts included, rounded to a whole number. Part credit must be allocated for part-time creditable experience, but one must not claim any real-time period more than once. Thus, someone who was a half-time research worker for two years while he or she was also a full-time university instructor cannot claim more than two years in total for that period.

	You should justify the relevance of any experience claimed, especially under item (C) above. In accordance with Clause 31.33 of the Collective Agreement, the interpretation of experience, employment and creditable years shall be in accordance with the past practice of the Association-Board Committee. Where there have been questions about the relevance of such experience, the Association-Board Committee has referred to the Job Description for the Instructor position at Dalhousie, and has sometimes consulted other sources, including the Department. You may be asked to elaborate further on your claim.							
	In the past, it was almost universally typical for a student to complete secondary education and immediately pursue a post-secondary degree, and possibly a graduate degree. This pattern is now often broken up, and periods of employment or other experience are							

interspersed with periods of education. Keeping in mind the rule that no real-time period may be claimed more than once, indicate whether any experience you claim was required (for example, as part of a Co-op program) in obtaining an educational degree to equivalent, otherwise such experience will be assumed to be unrelated to the educational experience

claimed.

For example, many graduate schools require students to work as either teaching or research assistants as part of the degree requirements. Such work will not be recognized as creditable experience in addition to the graduate degree credited.
