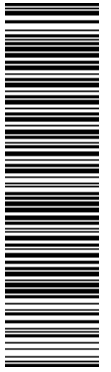

### Philippines tourist visa checklist

- ☐ **Filled out and signed Philippines tourist visa application form.** The form is enclosed.
- ☐ **Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- ☐ **Passport-type photographs: 1.** Must be 2 inches x 2 inches. Applicant must also sign the front of the photo.
- ☐ **Payment.** Credit Card Authorization form, Certified Check, or Money Order payable to **VisaHQ.ca**.
- ☐ **Return mailer.** Prepaid self-addressed return label or payment for FedEx.

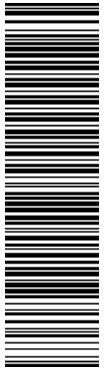
☐ **Proof of Status.** Copy of the front and back of valid Permanent Resident Card or other proof of legal status in Canada (such as study permit, work permit, refugee/protected person status document)

☐ **Itinerary. Original** itinerary with confirmed entry and exit dates including the applicant's name.

☐ **Bank Statement.** Original recent bank statement showing proof of sufficient funds. The statement must be printed and stamped by the bank.

**Non-Canadian applicants may be subject to additional fees and/or processing time, at the discretion of the Consul. Please plan accordingly.**

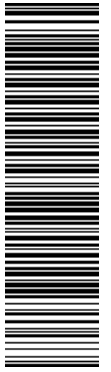

## TEMPORARY VISITOR'S VISA (FOR BUSINESS OR PLEASURE)

### A. VISA REQUIREMENTS FOR ENTRY INTO THE PHILIPPINES

1. Passport with validity period of six (6) months beyond the intended period of stay in the Philippines.
2. Application for visa FA-FORM NO. 2-A (REVERSE SIDE) duly accomplished, and submitted by the applicant in person. An applicant who cannot apply in person may apply by mail provided his/her duly accomplished application is **NOTARIZED**. Applicant who cannot personally pickup his/her document(s) should submit a self-addressed prepaid return envelope of a courier service of applicant's choice.
3. One (1) 4.5 cm x 3.5 cm photo of the applicant signed at the bottom front taken within the last 6 months from the date of application.
4. Original roundtrip airline ticket or travel itinerary plus a photocopy.
5. Proof of means of financial income or support i.e. bank statement, employment certificate, payroll slip, proof of pension, etc.
6. Visa fees: C\$40.50-single entry valid to be used within 3 months; C\$81.00-multiple entry valid to be used within 6 months; C\$121.50-multiple entry valid to be used within 1 year.
7. Non-Canadian passport holders need to submit a photocopy of proof of "**PERMANENT**" **RESIDENCY** in Canada i.e. permanent resident card, work permit card, etc.
8. Other documents that may be required by the Consular Officer.

**IMPORTANT NOTICE:** Fees and processing time may vary for non-Canadian passport holders

### B. TEMPORARY VISITOR FOR BUSINESS (Aliens attending international conferences or conventions in the Philippines, business meetings or bona fide businessman)

1. Requirements 1 to 7 identified under item A above.
2. A letter of certification identifying the applicant as bona fide businessman or letter of invitation to an international convention or business meetings and the means of financial support of the applicant during his/her stay in the Philippines. The letter must state the purpose of the trip.

### C. MINORS BELOW 15 YEARS OF AGE traveling to the Philippines not accompanied by a parent or not joining a parent in the Philippines need a Waiver of Exclusion Ground (WEG) from the Commissioner of Immigration in the Philippines. The following documents shall be submitted to the Philippine Bureau of Immigration at the port of entry:

1. Affidavits of Request and Consent and Guaranty by both parents or legally appointed guardian of the child naming therein the person who will be accompanying the child to the Philippines and with whom the child will reside in the country.
2. Original birth certificate of the child.
3. Clear photocopy of the data page of the child's passport and guardian's passport.

**WEG fee must be paid directly at the Bureau of Immigration upon arrival of the minor children at the port of entry.**

**Minors accompanied by one parent only should submit notarized letter of consent from the other parent or a court order stating that only one parent has legal custody of the minor.**

**Minors joining his/her parent(s) in the Philippines should show documentary proof that his/her parent(s) is/are in the Philippines.**

### D. **PERSONS exempt from visa requirements:**

Returning "*balikbayans* or former Filipinos" may enter the Philippines without a visa and stay for a period of one (1) year provided they have a passport valid for 6 months beyond intended stay in the Philippines, a roundtrip ticket and can present proof of former Philippine citizenship (e.g. old passport, birth certificate). Foreign spouses and children who are traveling with the *balikbayan* are included in the privilege. Nationals of countries which have diplomatic relations with the Philippines are generally allowed entry into the country without a visa for a stay of 30 days or less, provided the nature of trip is for tourism, they are holders of round trip or outbound airline ticket and their passports are valid for six (6) months beyond the intended stay in the Philippines. U.S. and Canadian passport holders are covered by this rule. (For other nationalities, please check with the Philippine Consulate General).

**NOTE:** All fees are payable only in cash or money order/bank draft/cashier's check made payable to the Philippine Consulate General. **Do not send cash in the mail.**  
Fees and processing time may vary for non-Canadian passport holders.
