\$250 Registration Fee per family in addition to Tuition due on or before May 28, 2015.

\$100 Early Bird Discount If Registration and Tuition are paid on or before August 28, 2015.

Payment Options - All families must utilize the FACTS Tuition Management Program unless Tuition and Registration are paid in full prior to August 28, 2015. Current families will automatically be re-enrolled into the FACTS Tuition Management Program on or after May 29, 2015.

Parishioner Status - To qualify for parishioner status, families must be registered with the parish; children must participate in appropriate sacramental preparation programs, participate at weekly mass and be consistent with offertory donations to the church. If you are an active parishioner at a parish without a school you must enroll in the Catholic Tuition Grant Program (CTGP) and be considered a parishioner for purposes of tuition as long you remain a member in good standing at your parish. CTGP forms have been sent with this tuition packet and are available in the school office.

Participating Status - As a Participating Parishioner or Participating Non-Parishioner you will be assigned to a Bingo Team and will be expected to work your assigned scheduled dates. Bingo is a major fundraising activity and is critical to the operation and upkeep of the school.

FACTS Tuition Management - The FACTS Tuition Management Program is designed to allow families to have the option of a payment plan. Eleven (11) monthly payments will be made automatically from a checking or savings account or by credit card. These payments will begin in August and continue through June 2016. There is an enrollment fee of \$38 per year as well as fees charged for insufficient funds. A convenience fee applies to credit card payments. The option of making payments on the 5th, 12th, 20th, or 27th of the month is available. If a family is in arrears after two months of failed electronic attempts by FACTS, the Business Manager must approve an acceptable arrangement or student enrollment at St. Andrew's Country Day School will be in jeopardy. The school has a right to legal action for non-payment of tuition and fees, and the parents will be responsible for the cost of collection.
