Topic

Writing can be a powerful form of persuasion, so reading and responding to an author's argument are

important skills to learn. In this essay, you will make the transition from analytical writing to argumentative writing, a common type of college writing.

Choose one of these following contemporary issues, take a clear position on it, and write a well-developed argumentative essay (4+ pages / 6+ paragraphs):

# 1. being bilingual v. English-only laws

# 2. crime and punishment (shame, three strikes, etc.)

Your essay should have a clear and specific thesis statement that previews your supporting paragraphs. You don't have to agree or disagree with any one of the authors; instead, you need to state a position and support it. Incorporate and analyze quotations from the related articles in *Models for Writers*. You may also include examples from your own experiences or the real world to support your thesis.

## Audience & Purpose

Assume that your reader is familiar with your topic but does not agree with your point of view. You will attempt to persuade your reader that your position is valid.

## Structure & Content Checklist

- \_\_\_\_\_ Write a creative title and hook for your essay.
- \_\_\_\_\_ Identify the authors and titles of the articles in your introduction. Your introduction should also explain the context or background of the debatable topic.
- \_\_\_\_\_ The thesis statement must specifically and directly state the main points and position of your essay.
- \_\_\_\_\_ Use clear topic sentences and transitions to provide a structure for your essay; do not begin or end a supporting paragraph with a quotation.

## Structure & Content Checklist cont.

- \_\_\_\_ Include one quotation from the book plus an outside example in each supporting paragraph.
- \_\_\_\_\_ Cite each quotation properly for example: "The ads underwrite the programs or content" (O'Reilly 597).
- \_\_\_\_\_ Use present-tense verbs to write about the articles from the book.
- \_\_\_\_\_ Write a strong conclusion that summarizes and wraps up the entire essay.
- \_\_\_\_\_ Make your best effort to edit and proofread your sentences.
- \_\_\_\_\_ Format your paper properly: double-spaced, one-inch margins, 12-point font such as Times New Roman.
