- D. Prior to my signing a contract with the Project Sponsor, the Project Sponsor provided, for my review, a copy of the Public Utility Commission of Texas approved "Customer Disclosure Form."
- E. The Project Sponsor has explained procedures for filing a complaint with TNMP, with the Public Utility Commission or the Texas Attorney General Office. Complaints filed with TNMP are for the sole purpose of evaluating Project Sponsor performance. TNMP will not intervene in any Project Sponsor/Customer disputes.
- F. By its acceptance of the project for participation in TNMP's Residential and Hard-to-Reach Standard Offer Program (hereafter, "the SOP Program"), I understand that TNMP does NOT:
 - 1) make any warranty or representation of any kind regarding installation or implementation of energy efficiency measures, the benefits to be derived from the measures, or the merchantability or fitness of the measures or installation for any particular purpose; or
 - 2) become a party to any contract between
