SPECIFIC VENDOR INFORMATION / TERMS OF PARTICIPATION:

- Desert Thunder (DT) will review each application for approval of appropriate products and services. DT reserves the right to refuse any vendor, product or service it deems inappropriate. Should a decline by DT occur, vendor will be notified and all vendor space rental fees will be returned. DT staff have the final decision. Please allow up to 14 days for approval notification.
- Vendor space is located in the Palace Station Hotel and Casino parking lot. Vendor space is rented in blocks of 10' X 10' as stand alone or in groups.
- Price per 10' X 10' is \$100 and includes two vendor passes (wristbands) to allow ingress and egress from the event venue. Additional wristbands may be purchased for \$10 each. **Deadline for "receipt" of application and payment is September 23, 2016.**
- **Electricity is available, when pre-ordered** by the space request deadline. The use of personal generators is not permitted.
- Telephone lines are not provided.
- Vendors must provide their own tents, sales trailer or other approved shelter.
- Vendors may unload and set up from 7 AM to 2 PM, Friday, October 7, 2016. All vehicles **MUST** be out of the vendor area **NO LATER THAN 2 PM**. Contact us to make early unload arrangements.
- All vendor spaces will be assigned by the appropriate DT staff. Participation is contingent on pre-approval by DT staff. Vendor spaces may not be split, shared, resold or sublet.
- ***All vendors must comply with all applicable tax laws and regulations of The City of Las Vegas, Clark County and the State of Nevada, including a working fire extinguisher in each booth.***
- Desert Thunder will consider a one-year website link on www.desertthunder.org to help promote its vendors. Vendor website must be pre-approved for content and will be monitored for appropriateness. Desert Thunder reserves the right to remove any link it deems inappropriate at any time.

TERMS OF PARTICIPATION (continued)

Cancellation of Space: 25% of rental costs will be forfeited by the vendor for cancellation of participation after August 31, 2016. All of rental costs will be forfeited after September 23, 2016. Event is held rain or shine.

I (we), the undersigned apply for the reservation of space during the Desert Thunder 2016 Event, October 7-9, 2016. When executed by both parties, this Agreement becomes binding between Desert Thunder, A Children's Charity (Event Organizer who agrees to rent space) and the approved applicant (Vendor who agrees to rent space) on terms contained herein.

Release of Liability: Neither Desert Thunder, A Children's Charity (its partners, representatives, volunteers, employees, official sponsors and official contractors), nor Palace Station Hotel Casino, Station Casinos (its partners, representatives, volunteers, employees, official sponsors and official contractors) will be liable for the safety of vendor's property, the vendor's agents or employees from theft, damage by fire or another cause. Vendor, for itself, its directors, officers, employees, agents, representatives, servants, licensees, invitees, patrons, guests, or contractors and their personal representatives, assigns, heirs and next of kin (herein referred to as "Vendor") releases, waives, discharges and covenants not to sue Desert Thunder – Children's Charities, their directors, officers, employees, agents, representatives, servants, licensees, invitees, patrons, guests, or contractors (herein referred to as "Releasees") and each of them, from all liability to the Vendor for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property resulting in death of Vendor arising out of or relating to the Desert Thunder, A Children's Charity event, whether caused by the negligence of the Releasees or otherwise. Vendor agrees to indemnify, save and hold harmless the Releasees and each of them from and against any loss, liability, damage or cost Releasees may incur from any and all claims, demands, actions, causes of actions, penalties, judgments, and liabilities of every kind and descript (including court costs and reasonable attorneys' fees) for injury to a or any death of persons, and damage to and loss of property which are caused by, arise from or grow out of this agreement. Vendor assumes full responsibility for any risk of bodily injury, death or property damage out of or related to Desert Thunder, A Children's Charity, whether caused by the negligence of Releasees or otherwise. Vendor provides proof of adequate and current liability insurance with aforementioned required Certificate of Insurance.
