If payment is past-due by 15 days, a phone call will be made to the responsible parent(s) of the student, and immediate payment will be expected. If payment remains past-due for 30 days, your child will not be allowed to attend class until payment is made.

Notification of withdrawal from the school for any purpose must be made at least 30 days in advance in writing. Attendance for any portion of the month will require payment of the full month's tuition.
