Re: Act 319 Proof of Income for Property Owners with less than 10 acres

Enrollment period January 1, 2016 through June 1, 2016

Dear Property Owner(s),

The Lancaster County Assessment Office implements a standard policy for Act 319 (Clean and Green) enrollees whose applications contain less than ten acres of contiguous land. Pursuant to the regulations for implementation of the Act (published March 31, 2001 by the Pennsylvania Department of Agriculture), such enrollees are required to demonstrate annual gross income of **at least \$2,000** from the production of agricultural commodities. In order to ensure enrollment in Act 319 for **tax year 2017**, proof of income must be shown for **three previous tax years (2015, 2014, and 2013).**

You may use *any one* of the following three methods:

- 1. Submit a photocopy of the appropriate Farm Income Schedule (typically Schedule F) from your federal income tax return. Please make note of how many acres are represented by the reported income.
- 2. Complete the enclosed Proof of Income Worksheets, and have all property owners (or authorized representatives thereof) sign the worksheets in the presence of a notary public.
- 3. Submit a notarized copy of your sales receipts for three previous tax years. The back of the Proof of Income Worksheet may be attached to the receipts for use by the notary public. Please make note of how many acres are represented by the received income.
