- 1. ELIGIBILITY:** The Von Miller ProCamp Sweepstakes (“Sweepstakes”) is open only to legal residents of Colorado who are 18 years of age or older as of 4/29/16. Winner is permitted to bring one guest to Experience. If the Event does not take place as scheduled, for reasons such as cancellation, preemption or postponement, or for any reason beyond the control of Sponsor, winner will receive no compensation. Winner and guests are solely responsible for all other expenses not specifically set forth herein, including but not limited to meals, transportation, souvenirs, room accommodations, and other incidentals and items of a personal nature. In the event a potential winner cannot be contacted, declines a prize, or cannot accept a prize at the date and time it is offered, or otherwise is unwilling or unable to accept a prize, the prize will be forfeited in its entirety and an alternate potential winner may be selected by random drawing from the remaining eligible entries, time permitting.
