Beginning Businessman Statement

To be completed and attached to the income tax return of a businessman claiming a beginning businessman income tax deduction

This statement facilitates the administration of the beginning businessman income tax deductions allowed under North Dakota Century Code §§ 57-38-71 through 57-38-74, and 57-38-01.2(1)(n). For a complete explanation of the beginning businessman income tax deduction provisions, including the definitions of *businessman* and *beginning businessman*, see *Income Tax Guideline: Beginning Businessman Income Tax Deductions*.

This statement has three parts: **Part 1** (**Beginning Businessman Certification**) must be completed in all cases by the individual who qualifies as a beginning businessman. **Part 2** (**Businessman Rental Certification**) must be completed by the businessman **ONLY IF** a deduction for net income from a lease contract is claimed. **Part 3** (**Net Worth Statement**) must be completed in all cases by the individual who qualifies as a beginning businessman.

This statement must be completed and attached to the businessman's North Dakota income tax return for each tax year in which a beginning businessman income tax deduction is claimed. The businessman may make copies of this statement, as needed, for this purpose. The businessman should also keep a copy.
