TERM OF REFERENCE (TORs)

- 3. Interested firms while quoting their rates are also required to provide following information for our perusal.
- a. Profile of the firm along with CVs of Chief Executive & Senior Management and complete address/telephone Fax, email etc. of its Head Office and Field Offices.

- b. Legal status whether partnership or company along with year of establishment and applicable supporting documents including license. Registered Partnership deed, article/Memorandum of Association etc.
- c. Financial reports for the last three years along with Bank statements/Certificate indicating financial standing.
- d. Bank statements/Certificate indicating financial standing.
- e. National Tax Number Certificate.
- f. An Affidavit that company has never been black listed by any Government/Semi Government or Autonomous body.
- g. Any other important information that firm wishes to furnish.
- h. Rate quoted must be for the entire agreement, during the currency of the agreement no request will be entertained for any enhancement of the rate on any ground. (Option to extend agreement for further period rate may also be quoted for the 2 years and 3 years respectively).
- 4. Applications along with requisite documents should be submitted in a sealed envelope marked as "Hiring of Drivers, Messengers and sweepers.
- 5. A pay order/Bank Draft of Rs.20,000/- must be attached with quotation as earnest money which will be return after selection of Company/Firm.
